You have requested to complete this horizontal well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of horizontal wells are to be located no closer than 330 feet to the exterior boundary of a standard 320 - acre spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 100 feet to the eastern and western edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 34, encroachment to the SW/4
Section 31, encroachment to the SE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

The Division understands you are seeking this unorthodox location in order to increase the ultimate recovery of reserves within the Wolfcamp formation underlying the S/2 Section 33 and the S/2 Section 31, thereby preventing waste of natural resources.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

WPX Energy Permian, LLC (“WPX”), OGRID No. 246289, is seeking administrative approval of an unorthodox well location (“NSL”) for the Frontier 33-32 Fed Com 603H Well (the “603H Well”) (API No. Pending) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying a standard 640-acre, more or less, horizontal spacing unit comprised of the S/2 of Sections 33 and 32, Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Location (SL): 1,420’ from the South line and 259’ from the East line (Unit I) of Section 33, Township 23 South, Range 26 East;
- Bottom Hole Location (BHL): 2,310’ from the South line and 20’ from the West line (Unit L) of Section 32, Township 23 South, Range 26 East;
- First Take Point (FTP): 2,310’ from the South line and 100’ from the East line (Unit I) of Section 33, Township 23 South, Range 26 East;
- Last Take Point (LTP): 2,310’ from the South line and 100’ from the West line (Unit L) of Section 32, Township 23 South, Range 26 East.

WPX has included as Exhibit B, a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp Pool (Pool Code 98220). The special Division rules for the Purple Sage; Wolfcamp Pool establish 330' foot setback requirements which are laid out in Order No. R-14262. The first and last take points for the proposed well are closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the SW/4 of Section 34 and the SE/4 of Section 31, all in Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico.

WPX attests that, on or before submission of this application, it provided notice to the affected persons in the adjoining SW/4 tract of Section 34 and the adjoining SE/4 tract of Section 31, all in Township 23 South, Range 26 East, NMPM, Eddy County, New Mexico; said notice as described satisfies all provisions of 19.15.4.12A (2) NMAC; copies of the application and required plat maps were furnished. WPX has also provided notice to the Bureau of Land Management and to the New Mexico State Land Office to the extent that federal and state leases are involved, pursuant to 19.15.2.7A(8)(d) NMAC. WPX provides herein a sectional map of this area, attached as Exhibit C. Proof of mailing, along with a copy of the notice letter sent to listed affected persons and parties, is attached hereto as Exhibit D. The pooling case associated with this application is Case No. 25205.



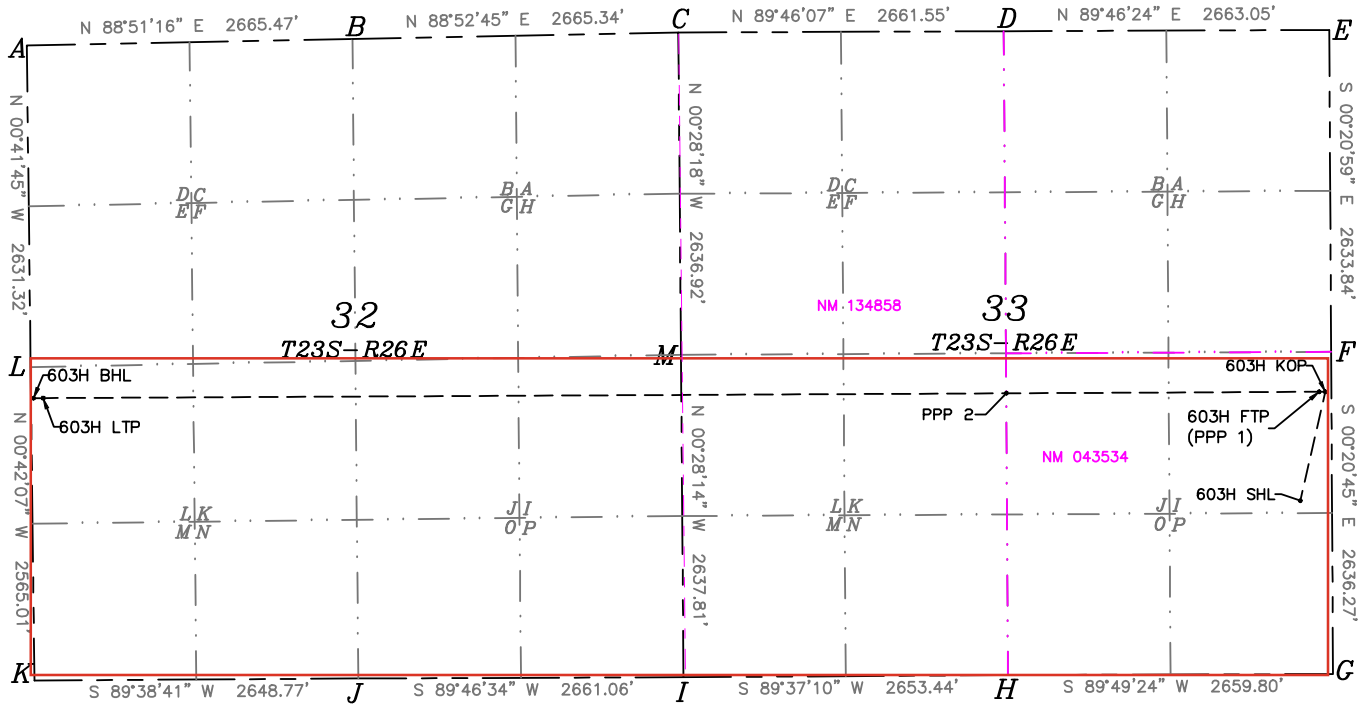

WPX Energy Permian, LLC ("WPX"), a subsidiary of Devon Energy Production Company, L.P., respectfully requests administrative approval of a non-standard location ("NSL") for each of the Wells referenced above. The Wells are in the Purple Sage-Wolfcamp Gas Pool (Pool Code 98220). It is Devon's responsibility as a prudent operator to minimize reserves left in the ground. Decreasing the first and last take point from three hundred and thirty feet (330') to one hundred feet (100') will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.

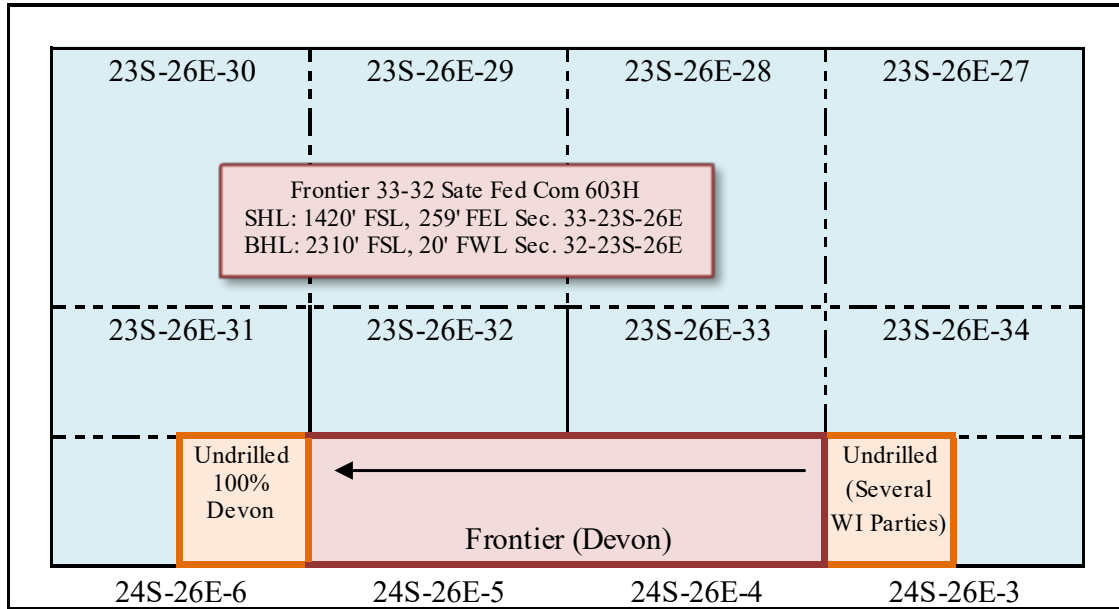
