We understand that you are seeking this exception for an allowance to create a non-standard horizontal spacing unit, comprised of the Proposed Horizontal Spacing Unit referenced above within Eddy County, New Mexico.

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units which are to be being included.

You have requested this non-standard horizontal spacing unit due to surface restrictions access, to develop a single drill island, to carefully place well bores and to optimize geological and production potential within the Bone Spring formation underlying all of Section 22 and Section 15 within the referenced Horizontal Spacing Unit. Therefore, protecting correlative rights within the pool/formation.

Pursuant to the authority conferred by Division Rule 19.15.16.15(B)(5) NMAC, the above-described **non-standard horizontal spacing unit is hereby approved**. Further, the Applicant may add additional wells to the non-standard spacing unit, the well(s) must be in the same horizontal spacing unit and pool/formation. Devon Energy Production Company, L.P. (“Devon”) respectfully requests administrative approval of a non-standard spacing unit for the Tiger King Wells referenced above. The wells are in the Gatuna Canyon; Bone Spring Pool (Pool Code 96688).

Devon’s development plans for Sections 22 and 15 encompass the entire 1,280-acre area, more or less. Due to restricted surface access and our obligation as a prudent operator to develop each formation from a single drill island, we must carefully plan wellbore placement and locations to optimize both the geology and production potential across these two contiguous sections.


Devon has a responsibility to be a prudent operator and approval of the non-standard unit would allow Devon to set up facilities and operations in a prudent manner that provides for the efficient development of these sections and avoids waste, pursuant to Section 70-2-3 of the Oil and Gas Act, by eliminating the unnecessary duplication of production facilities, Communitization agreements, and/or any comingle issues, thus bolstering revenue from production and protecting correlative rights.

For the foregoing reasons, Devon is requesting approval of the non-standard unit.
