Attached is updated water well sampling information associated with Blackbuck's C-108 for the Justice SWD #1 (pEG2528350098; SWD-2675) based on our continued water well owner contact efforts.

One water well sample was collected within the 1-mile sampling radius and discussions with the owner of the remaining two candidate water wells confirmed that the water wells are no longer in use. The updated water well table (updated information in blue text) and map, as well as the lab report associated with the water sample are attached for your review and inclusion in the record.

Please let me know if you have any questions or need further information on the water sampling or C-108 itself.

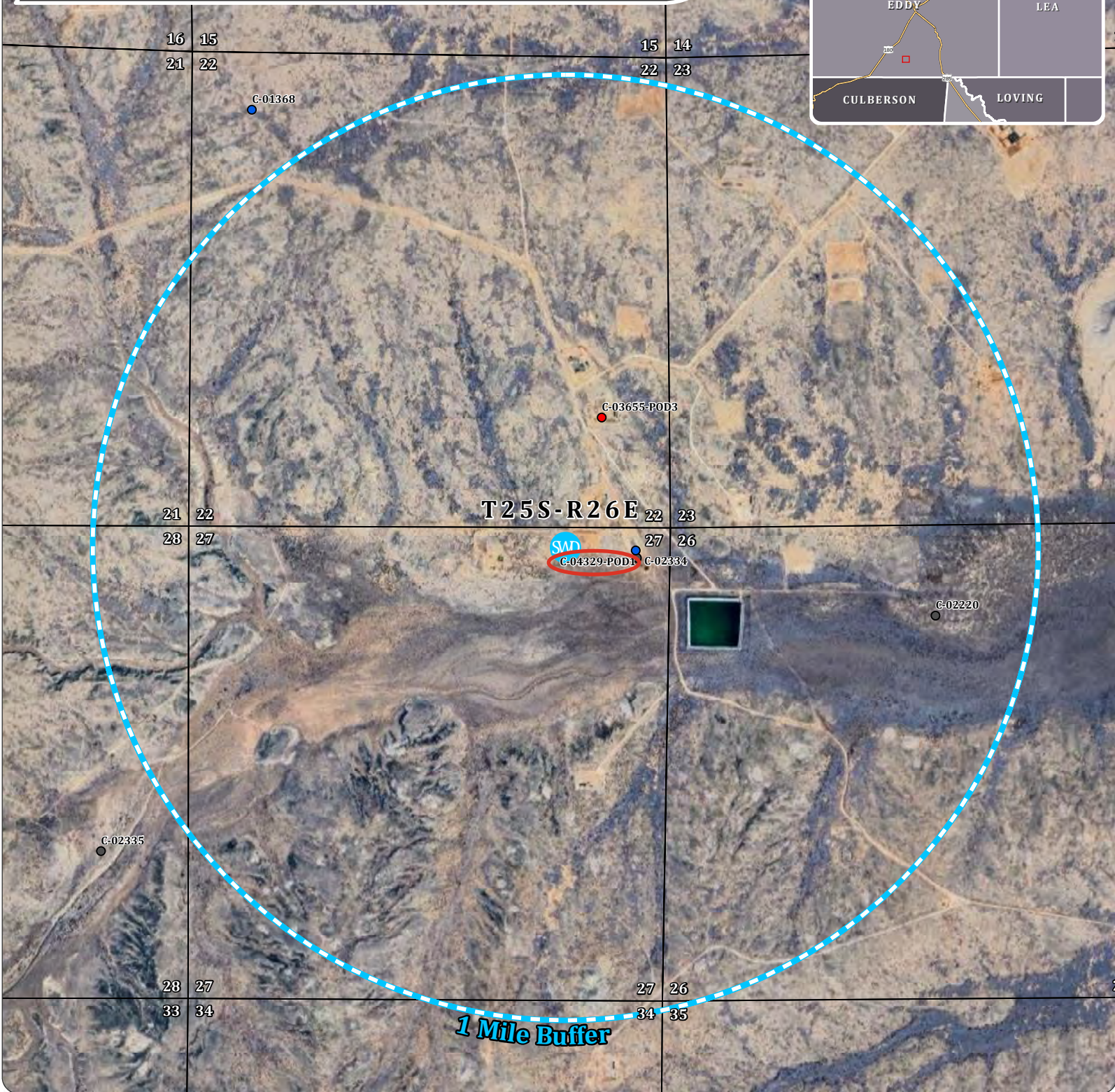
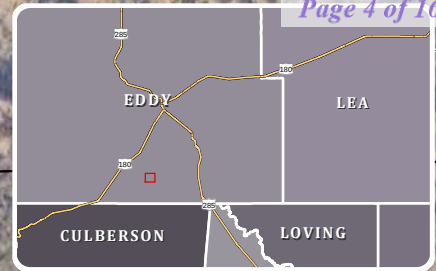
