You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(3)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **gas** well a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the

completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 660 feet for a **gas** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 330 feet for a **gas** in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 100 feet to the eastern and western edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 33, T21S R27E, encroachment to the SW/4
Section 35, T21S R26E, encroachment to the SE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location in order to maximize lateral length, to properly place stimulation energy, and to optimize pressure drawdown within the Wolfcamp formation underlying Section 32, (T21S, R27E), Section 31, (T21S, R27E) and Section 36, (T21S, R26E). Therefore preventing waste, and protection of correlative rights.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.

- Bottom Hole Location: 691' FSL and 54' FWL, Section 36, Township 21 South, Range 26 East

The completed interval of the well will be unorthodox because it will be located less than 330 feet from the western and eastern boundaries of the offsetting spacing units. As explained in the engineering statement, included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian Resources to maximize lateral length, properly place stimulation energy, and optimize pressure drawdown, which will prevent waste and protect correlative rights.

Exhibit B is a Form C-102 showing the location of the Fred State Com 132H well in relation to the offset tracts.

Exhibit C is a plat that shows the Fred State Com 132H well in relation to the adjoining tracts. Permian Resources is the offset operator to the east. 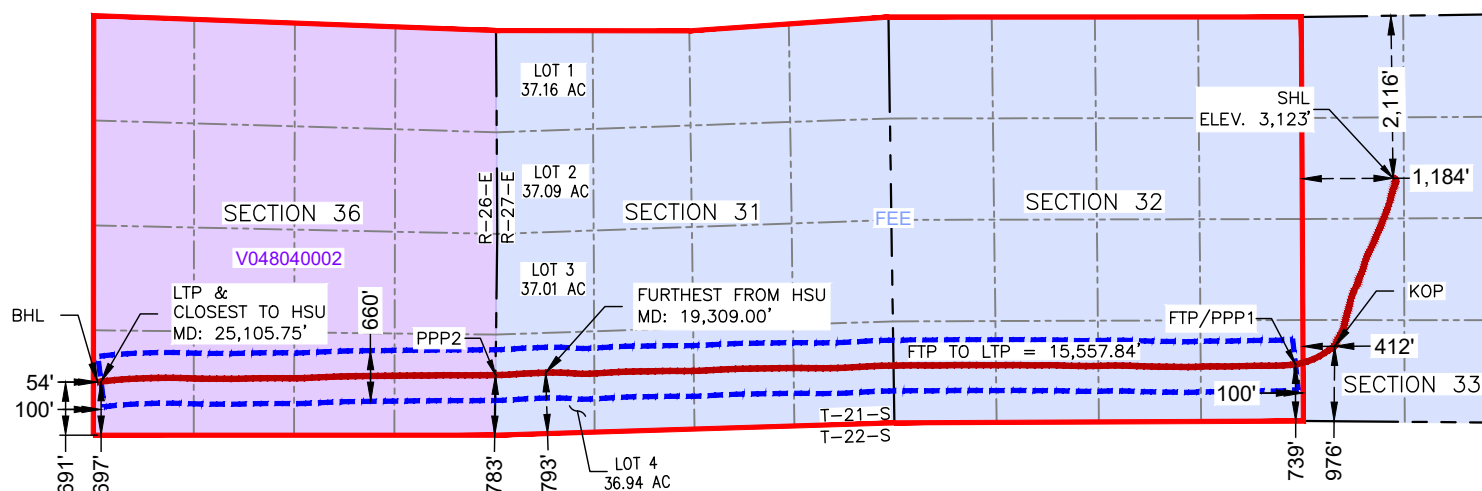

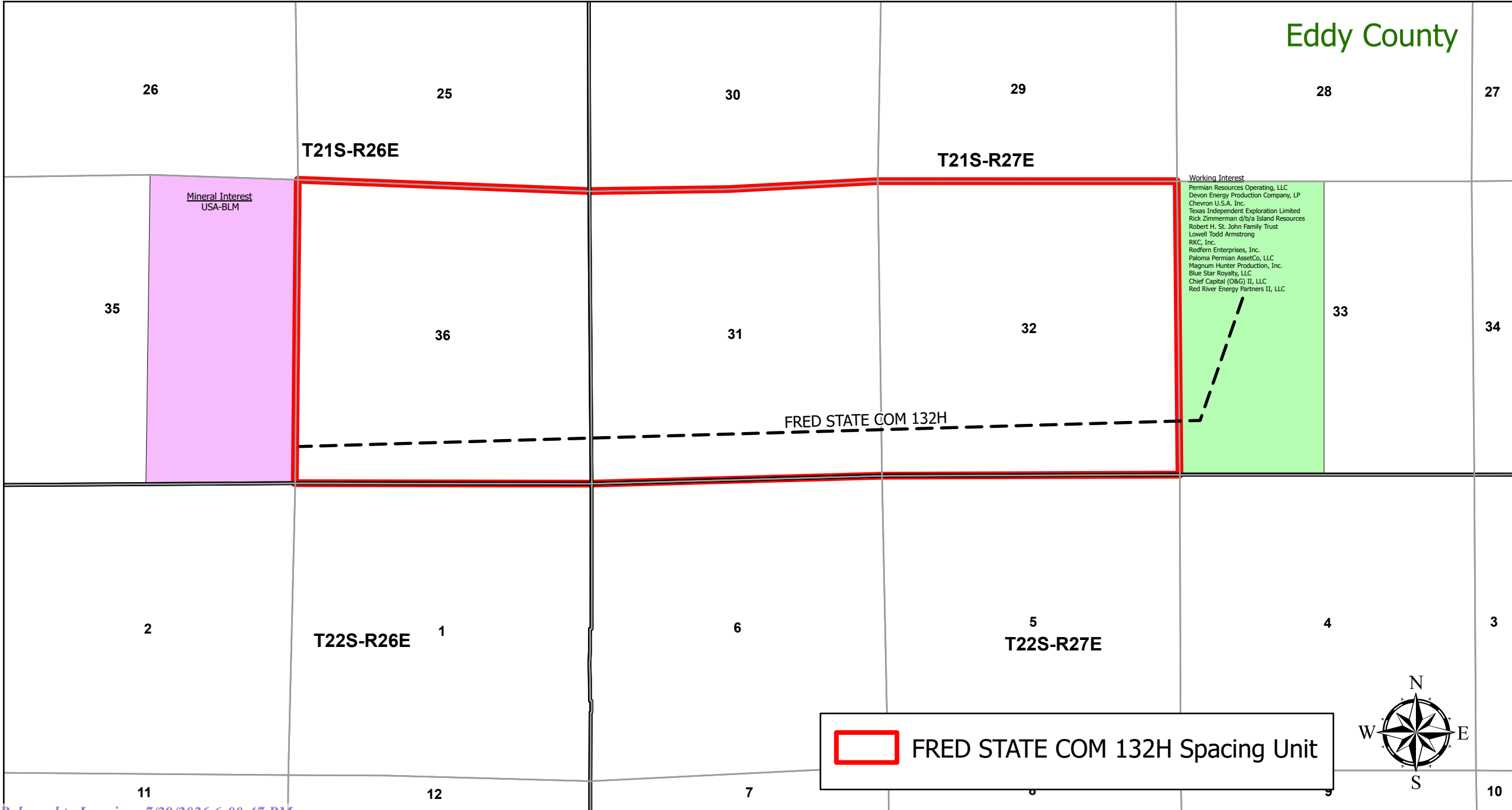

Enclosed is a copy of an administrative application requesting approval of a non-standard well location for Permian Resources Operating, LLC's ("Permian Resources") Fred State Com 132H well. An administrative application for the above-referenced non-standard location was filed with the New Mexico Oil Conservation Division on this date.
