Greetings Ms. Neal:

Reference is made to your request on behalf of Forty Acres Energy, LP (OGRID 320052; the “operator”) for the application received on June 25, 2026, to increase the maximum surface injection pressure (“MSIP”) on the following wells:

It is our understanding that the requested pressure increase is needed to achieve the desired injection rate to maintain pressure support and to overcome increased reservoir pressure and perforation entry pressure. The pressure increase will not result in:

1. the fracturing of the permitted disposal interval;
2. the fracturing of either the upper or lower confining strata; or
3. induced-seismic events as a consequence of the higher injection pressure.

Based on the results of the submitted step rate injection test, the following shall be the new pressure limit while equipped with 3.5-inch injection tubing:

This approval is based on the provision that the tubing size, packer setting depth and completion interval for the well does not change, and the increased pressure is applied only to wells with offset production. Any future requested pressure increase will require resubmission of additional data and/or a new step-rate test. The Director retains the right to require, at any time, wireline verification of completion and packer setting depths in the well and to request that a step rate test be repeated in any well to confirm fracturing is not occurring. This approval is subject to your being in compliance with all other OCD rules including, but not limited to, Rule 19.15.5.9 NMAC.

The Director may rescind any injection pressure increase permit if it becomes apparent that the injected fluid is not being confined to the permitted disposal interval, impacts correlative rights, is endangering any freshwater aquifer or endangers public health and safety.
