You have requested to complete this horizontal well described above in the referenced pool or formation. This well is governed by special rules R-14262, for the Purple Sage; Wolfcamp (Gas) Pool and governs wells to be located at least 330 feet from the unit outer boundary of a spacing unit and no closer than 10 feet to any quarter – quarter section line. The completed intervals of

It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

The well's completed interval is as close as 100 feet to the western and eastern edge of the horizontal spacing unit. Encroachment will impact the following tract(s).

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location in order to maximize the recovery of oil and gas reserves within the Wolfcamp formation underlying all of Section 04 and all of Section 03. Thus, preventing waste and protecting correlative rights of all affected parties.

Pursuant to Division Rule 19.15.16.15(B)(1)(a), Mewbourne Oil Company (“Mewbourne”) respectfully requests administrative approval of an unorthodox gas well location for the above captioned well. This well will be drilled as a horizontal gas well in the Purple Sage Wolfcamp; Gas Pool (98220). The above well will be dedicated to a 1279.56-acre gas spacing and proration unit comprising All of Section 4 and All of Section 3.

The Purple Sage Wolfcamp; Gas Pool is currently governed by Statewide Horizontal Well Rule 19.15.16.15(C)(1)(b) which governs the first and last take point of a horizontal well and states they shall be no closer than 330 feet in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The unorthodox location is necessary in order to maximize the recovery of oil and gas reserves from the Wolfcamp formation underlying All of Section 4 and All of Section 3.

The affected offset acreage comprises the E/2E/2 of Section 5 and the W/2W/2 of Section 2, Township 22 South, Range 26 East, NMPM (See Attached Map), which is operated by Mewbourne Oil Company and Earthstone Operating, LLC.

Attached is a Form C-102 showing the surface, first take point, and bottomhole locations for the above captioned well. Also, attached is a map showing the affected offset acreage, a horizontal well plan, and a notice list.

In summary, approval of the application will provide Mewbourne Oil Company the opportunity to recover additional oil and gas reserves from the Purple Sage Wolfcamp; Gas Pool underlying All of Section 4 and All of Section 3 that may otherwise not be recovered, thereby preventing waste, and will not violate correlative rights.

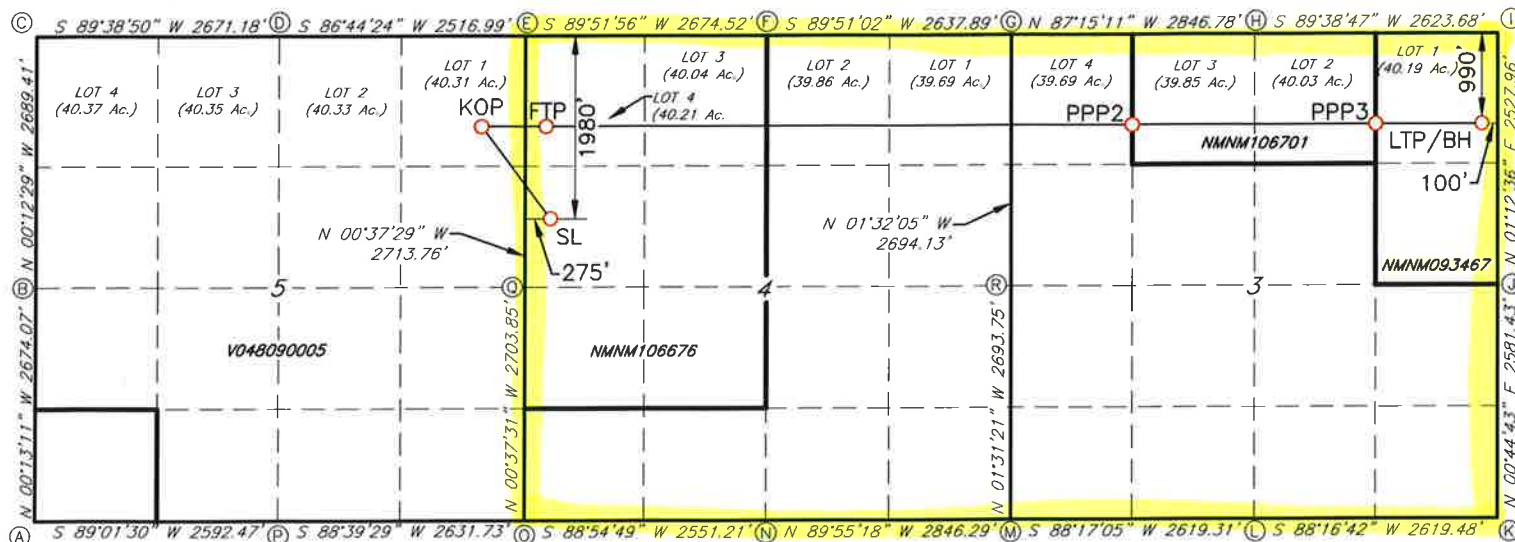

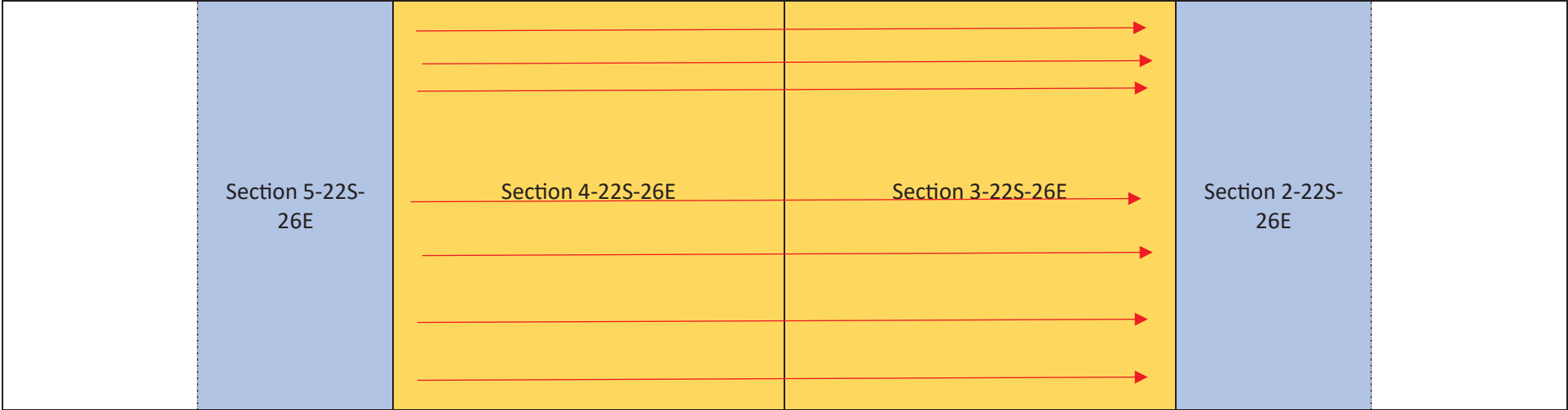

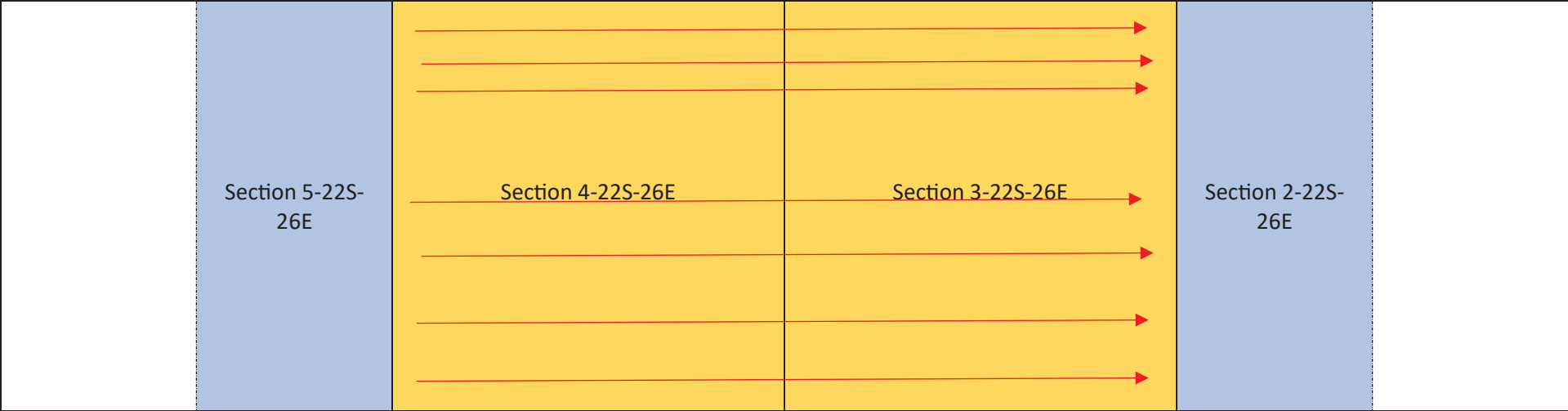
