You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(3)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **gas** well a standard horizontal spacing

unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 660 feet for a **gas** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 330 feet for a **gas** in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 100 feet to the eastern edge, 315 – 503 feet to the northern edge and 100 feet to the western edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 33, T21S, R27E, encroachment to the NW/4
Section 29, T21S, R27E, encroachment to the S/2
Section 30, T21S, R27E, encroachment to the S/2
Section 25, T21S, R26E, encroachment to the S/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location in order to obtain maximize lateral length, to properly place stimulation energy and to optimize pressure drawdown, creating cost efficiencies. Therefore, preventing waste and protecting correlative rights within the Wolfcamp formation underlying Section 32, T22S, R27E, Section 31, T22S, R27E and Section 36, T22S, T26E.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

In accordance with Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC, Permian Resources Operating, LLC ("Permian Resources") (OGRID No. 372165) seeks administrative approval of an unorthodox well location for the Fred State Com 122H well, in a 1,908.20 acre, more or less, standard horizontal spacing unit, comprised of the all of Sections 31 and 32, Township 21 South, Range 27 East and all of Section 36, Township 21 South, Range 26 East, Eddy County, New Mexico.

- Bottom Hole Location: 342' FNL and 57' FWL, Section 36, Township 21 South, Range 26 East

The completed interval of the well will be unorthodox because it will be located less than 330 feet from the western and eastern boundaries of the offsetting spacing units, as well as less than 660 feet from the southern boundary of Section 29 and 30, Township 21 South, Range 27 East, and Section 25, Township 21 South, Range 26 East. As explained in the engineering statement, included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian Resources to maximize lateral length, properly place stimulation energy, and optimize pressure drawdown, which will prevent waste and protect correlative rights.

Exhibit B is a Form C-102 showing the location of the Fred State Com 122H well in relation to the offset tracts.

Exhibit C is a plat that shows the Fred State Com 122H well in relation to the adjoining tracts. Permian Resources is the offset operator to the east. Therefore, notice was provided to the interest owners in the adjoining tract. The notice list attached as Exhibit D identifies all offset owners who were provided notice of this application.

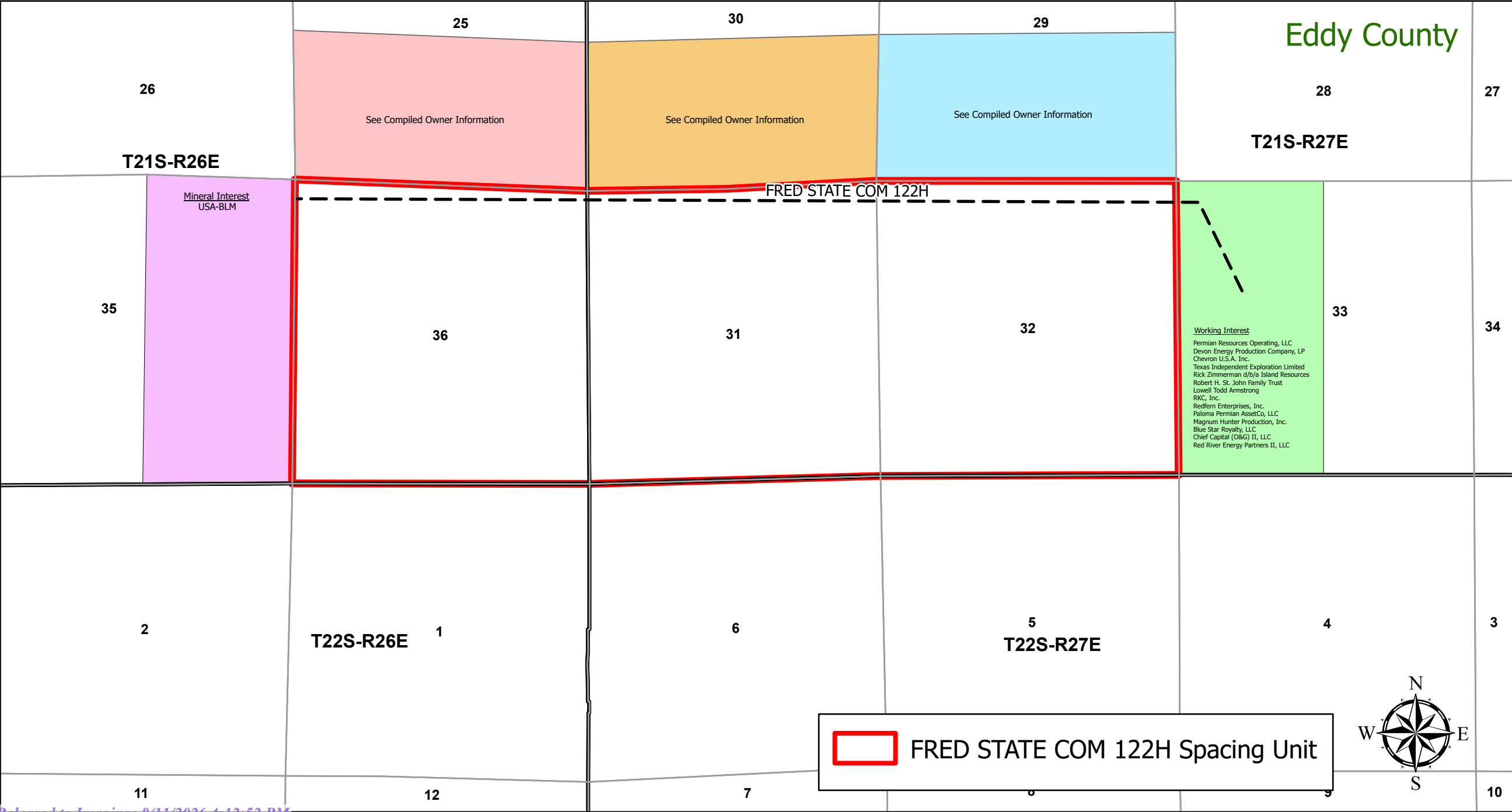
