You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(3)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **gas** well a standard horizontal spacing

unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 660 feet for a **gas** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 330 feet for a **gas** in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 100 feet to the western and eastern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 24, encroachment to the SE/4
Section 22, encroachment to the SW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location for optimal spacing, to maximize lateral length, for stimulation energy and to optimize pressure drawdown. While creating cost efficiencies, therefore preventing waste and protecting correlative rights within the Wolfcamp formation underlying all of Section 19, Section 20 and Section 21.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.

In accordance with Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC, Permian Resources Operating, LLC ("Permian Resources") (OGRID No. 372165) seeks administrative approval of an unorthodox well location for the Solstice Fed Com 134H well, which is located in a 1,923.55 acre, more or less, standard horizontal spacing unit, comprised of all of Sections 19, 20, and 21, Township 21 South, Range 26 East, Eddy County, New Mexico.

The completed interval of the well will be unorthodox because the well is located in a gas pool and will be located less than 330 feet from the offset spacing units to the east and west. As explained in the engineering statement, included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Permian Resources to maximize lateral length, properly place stimulation energy, and optimize pressure drawdown, which will prevent waste and protect correlative rights.

Exhibit B is a Form C-102 showing the location of the Solstice Fed Com 134H well in relation to the offset tracts.

Exhibit C is a plat that shows the Solstice Fed Com 134H well in relation to the adjoining tracts. Notice was provided to the offset operators to the west of the unorthodox well location, as well as royalty interest owners of the offset tracts. Permian Resources is the offset operator to the east, therefore, notice was provided to working interest owners in the east. The notice list attached as Exhibit D identifies all offset operators and royalty interest owners who were provided notice of this application.

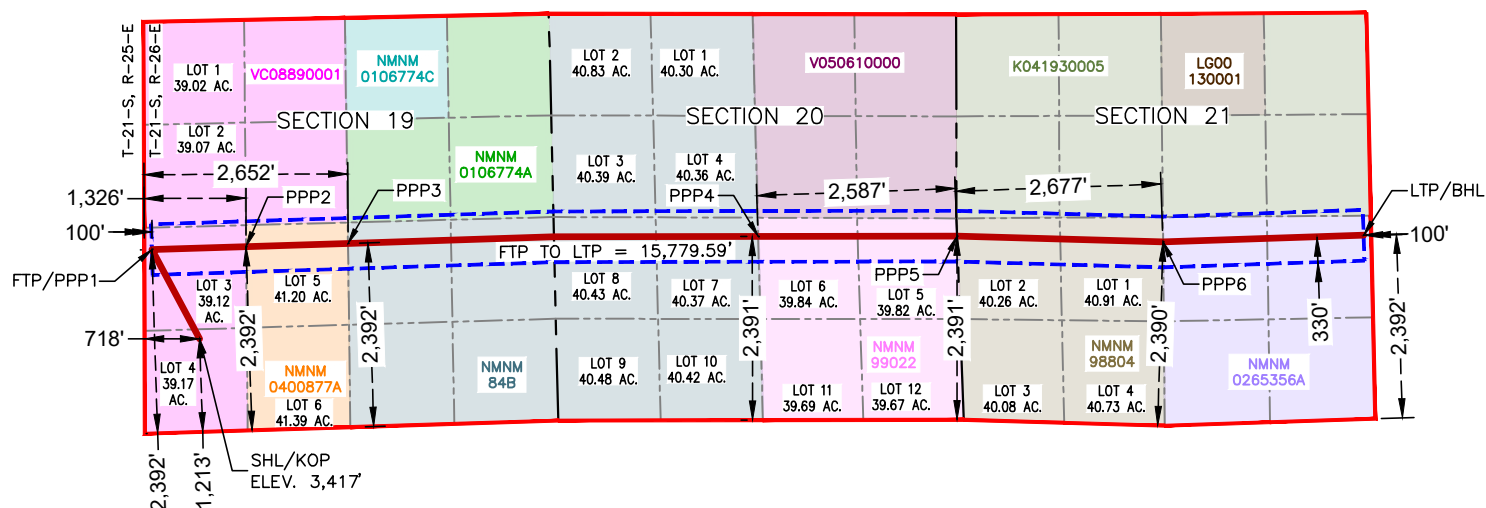

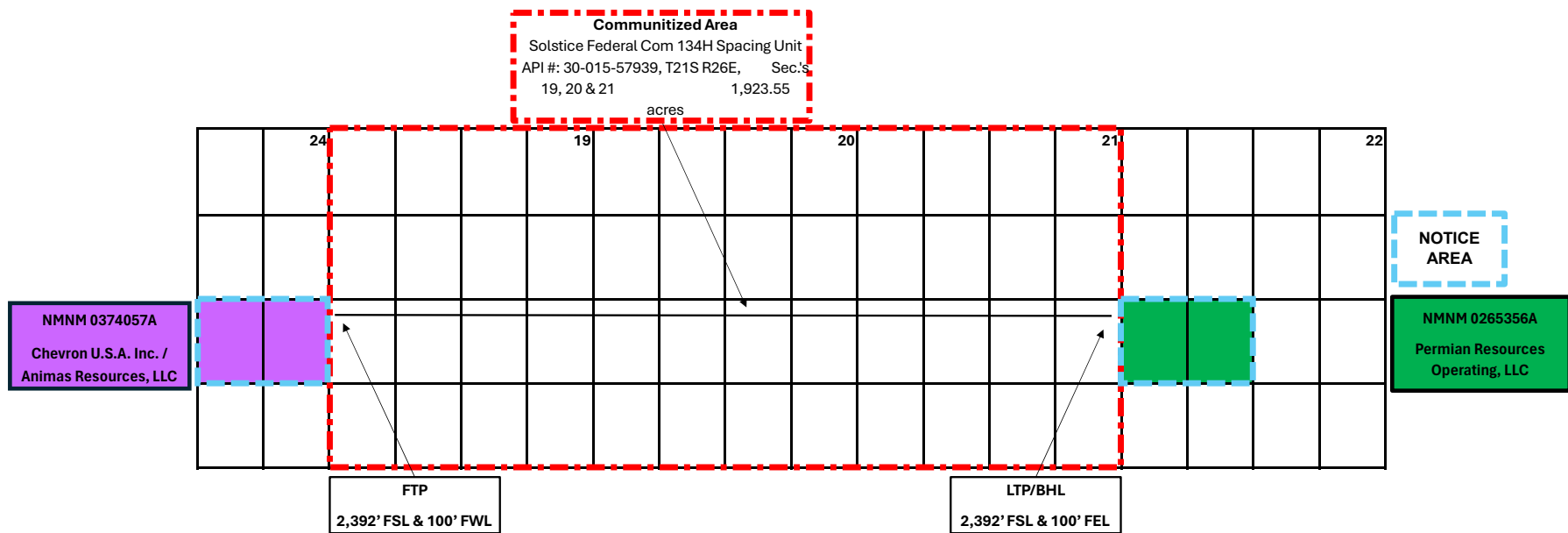
