You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(3)(a) NMAC governs this proposed well and provides that the operator shall dedicate to each horizontal **gas** well a standard horizontal spacing

unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 660 feet for a **gas** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 330 feet for a **gas** in the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is as close as 100 feet to the northern and southern edge of the horizontal spacing unit. However, encroachment concerns only impact the following tract(s) residing within OCD's jurisdiction.

Section 08, encroachment to the SW/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location in order to maximize the lateral length of this well. Therefore, preventing waste within the Wolfcamp formation underlying Section 17, Section 20, Section 29 and (equivalent) Section 32.

Your application has been filed under 19.15.16.15(C)(6) NMAC, 19.15.15.13 NMAC and 19.15.4.12 (A)(2) NMAC.

Per 19.15.15.13 (B) NMAC, **Division approves this unorthodox location.**

Reference this NSL order number on the As Drilled C-102 submitted with the Authorization to Transport, to place this well into production.

In accordance with Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC, Devon Energy Production Company, L.P. - Bottom Hole Location: 20' FSL and 924' FWL, Section 32, Township 26 South, Range 34 East

The completed interval of the wells will be unorthodox because the well is located in a gas pool and will be located less than the Division's required setbacks from the offsetting spacing units to the north and south, for the Bradley; Wolfcamp (Gas) Pool (Code 72860). As explained in the engineering statement, included as **Exhibit A**, approval of the unorthodox, completed interval is necessary to allow Devon to maximize lateral length, which will maximize reserves, prevent waste, and protect correlative rights.

**Exhibit B** is a Form C-102 showing the location of the Green Wave 17-32 Federal Com 840H well in relation to the offset tracts.

**Exhibit C** is a plat that shows the Green Wave 17-32 Federal Com 840H well in relation to the adjoining tracts. Notice was provided to the operators, mineral owners, and record title owners in the offset tracts. The notice list attached as Exhibit D identifies all affected persons who were provided notice of this application.

Devon Energy Production Company, L.P. ("Devon") respectfully requests administrative approval of non-standard location for the Green Wave 17-32 Federal Com 840H well (the "New Well"). The New Well was assigned the Bradley; Wolfcamp (Gas) Pool (Pool Code 72860) by the NMOCD. Devon has drilled multiple Green Wave Wolfcamp wells ("Existing Wells") in the same sections as the New Well. The Existing Wells were assigned an oil pool and produce with gas-oil ratios (GOR) below the NMOCD's definition of a gas well, therefore the Existing Wells were able to maximize GPI by utilizing oil pool setbacks at the heel and toe.

Devon expects the New Well to produce with a GOR similar to the Existing Wells; therefore Devon proposes to decrease the first and last take points from 660 feet to 100 feet, which will increase the completed horizontal lateral and the ultimate recovery of reserves. Therefore, approval of this non-standard location is necessary to avoid causing wasted resources and reducing production from current and future well development in the area.

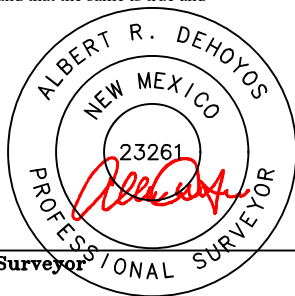

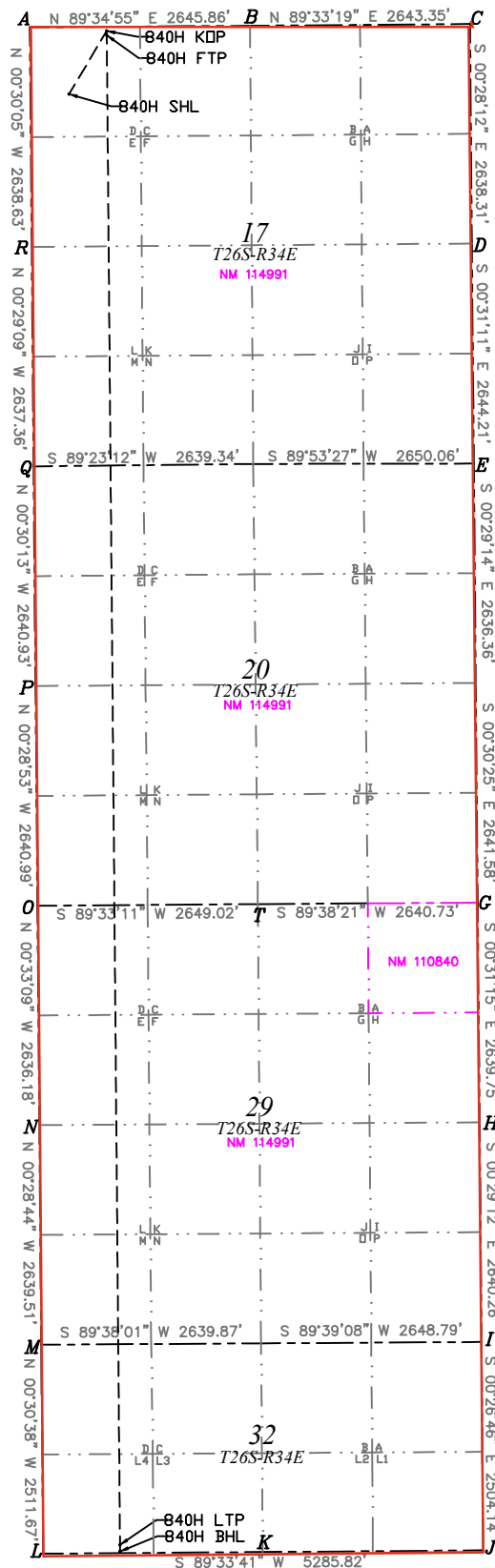

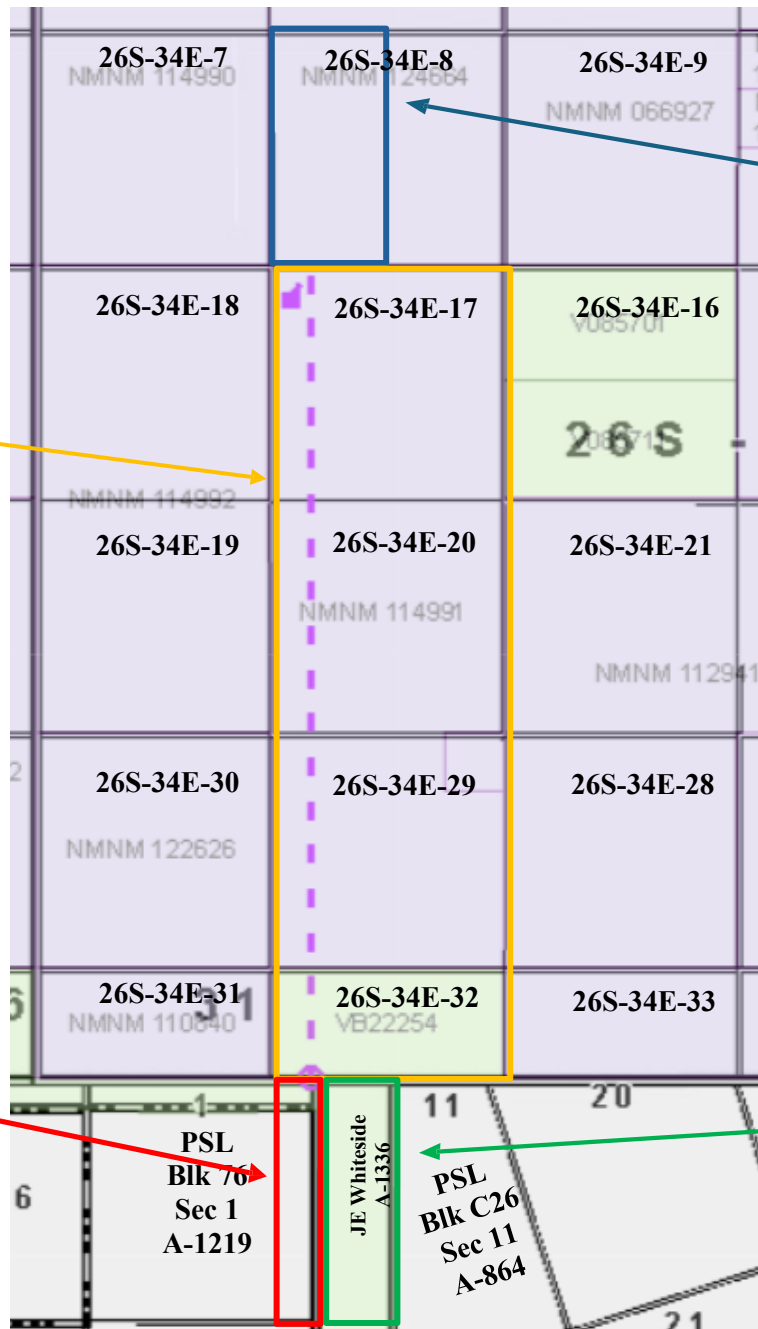
