You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(1)(a) NMAC governs this proposed well and provides that the operator dedicate a horizontal well at a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter - quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 330 feet

for an **oil** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 100 feet for a well within the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is 100 feet to the southern edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 12, encroachment to the N/2 N/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

EOG Resources, Inc. ("EOG") (OGRID No. 7377), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the Willow Lake; Bone Spring, West [96415], seeks administrative approval of an unorthodox well location for its Padron 3 State BS Unit 500H well (API No. 30-015-PENDING), in a 960-acre, more or less, spacing unit underlying the S/2 of Sections 1-3, Township 25 South, Range 27 East, NMPM, Eddy County, NM.

The location of the **Padron 3 State BS Unit 500H** oil well is as follows:

- Surface location: 1,807' FSL and 987' FWL (Unit L) of Section 3
- First take point: 100' FSL and 100' FWL (Unit M) of Section 3
- Last take point: 100' FSL and 100' FEL (Unit P) of Section 1
- Bottom hole location: 100' FSL and 100' FEL (Unit P) of Section 1

Since this acreage is governed by the Division's statewide rules, a portion of the lateral for this well will be unorthodox because it is closer than the standard offsets along the boundary of the Padron Unit—thus encroaching on the N/2 N/2 of Section 12.

EOG respectfully requests administrative approval of a non-standard location for the **Padron 3 State BS Unit 500H**. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox interval is necessary because EOG's technical team believes it will

allow for the most efficient development of this acreage, thereby preventing waste and protecting correlative rights.

Exhibit B is a Form C-102 showing that the lateral of the Padron 3 State BS Unit 500H well encroaches on the tracts to the south, specifically the tracts comprising the N/2 N/2 of Section 12 that is outside of the Padron Unit. This well is dedicated to two pools; however, the portion that encroaches along the outer boundary is in the Willow Lake; Bone Spring, West [96415], therefore EOG is only required to seek approval for a non-standard well location as it relates to this pool. Thus, the C-102 included is specific for the Willow Lake; Bone Spring, West [96415] and the plat included outlines in red the portion of the spacing unit dedicated to this pool and the acreage listed (480-acres) reflects the spacing unit acreage within this pool.

Exhibit C is a plat for the subject area that shows the Padron 3 State BS Unit 500H well in relation to the offsetting adjoining tracts to the south that the well encroaches upon. The affected tracts include state and fee lands, as explained by the landman statement attached. Accordingly, the “affected persons” are the New Mexico State Land Office (“NMSLO”) and the following working interest owners: The Allar Company, Inc., EG3, Inc., COG Operating, LLC, Concho Resources, Inc., and Devon Energy Production Company, LP. Also included is a diagram of the Padron Unit for reference.

Exhibit D is a spreadsheet listing all affected persons and includes tracking information demonstrating that each of the affected persons was sent a copy of this application with all attachments by certified mail advising that any objections must be filed in writing with the Division within 20 days from the date the Division receives the application. 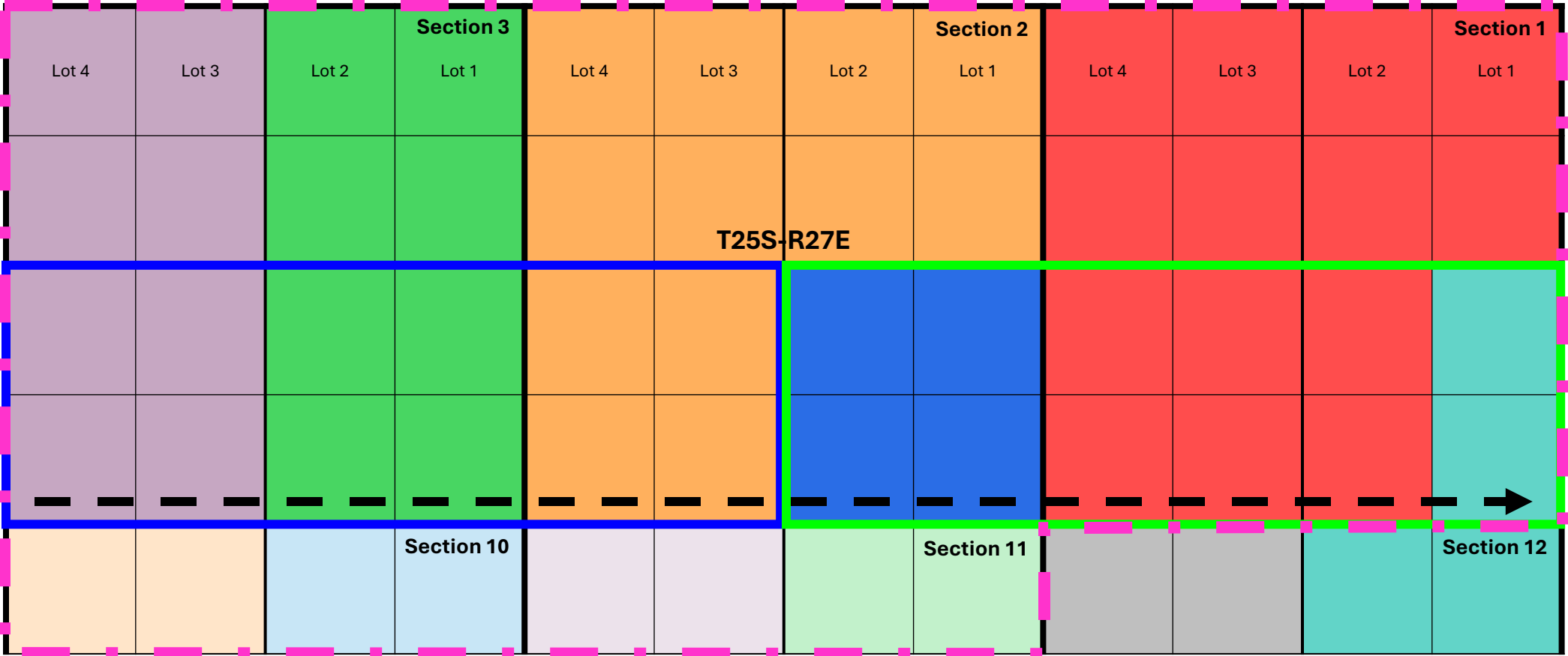

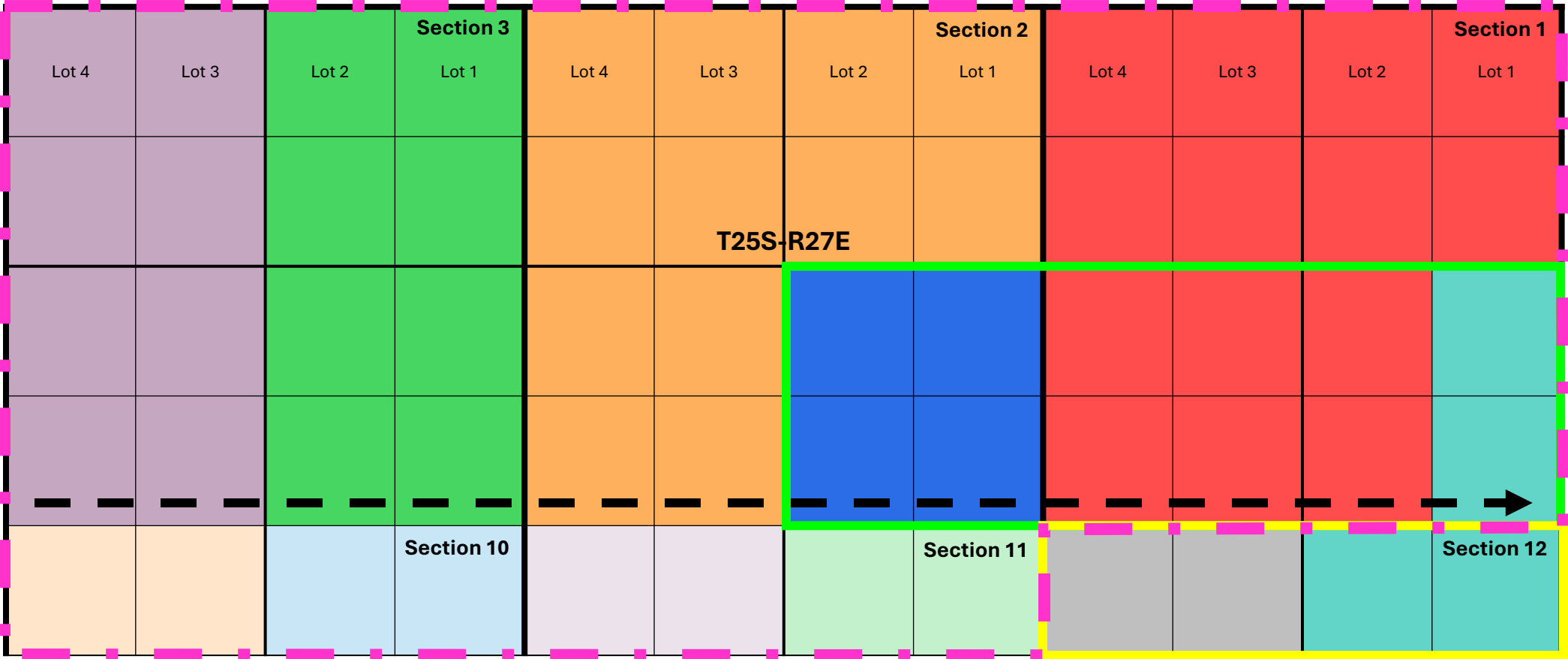

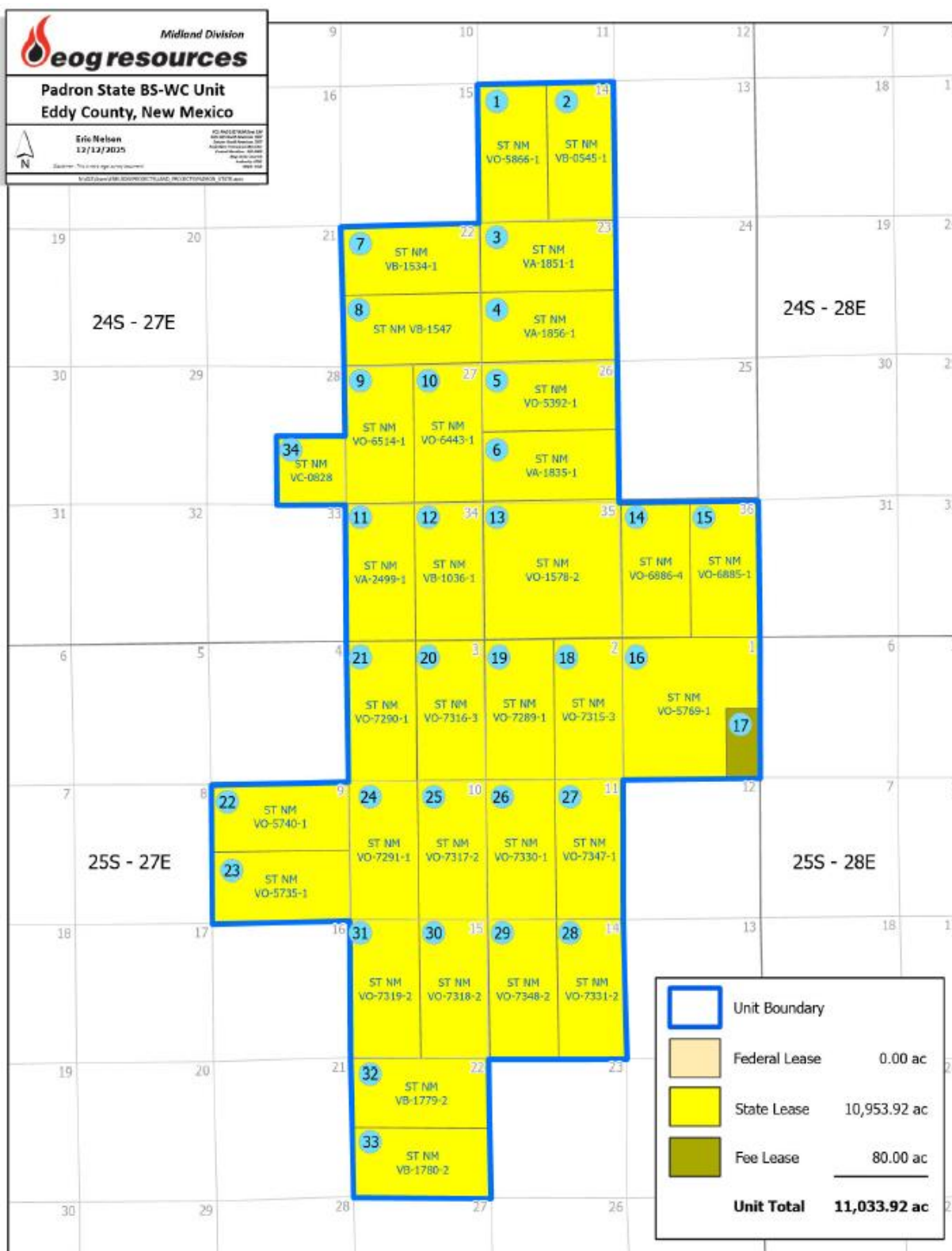
