You have requested to drill this horizontal well at an unorthodox well location described above in the referenced pool or formation. 19.15.16.15(B)(1)(a) NMAC governs this proposed well and provides that the operator dedicate a horizontal well at a standard horizontal spacing unit that comprises of one or more contiguous tracts that the horizontal well's completed interval penetrates, each of which consists of a governmental quarter - quarter section or equivalent. 19.15.16.15(C)(1)(a) NMAC governs the distance in the horizontal plane from any point in the completed interval to any outer boundary of the horizontal spacing unit, measured along a line perpendicular to the completed interval or to the tangent thereof, shall be a minimum of 330 feet

for an **oil** well. 19.15.16.15(C)(1)(b) NMAC governs the first and last take point of a horizontal well shall be no closer than 100 feet for a well within the horizontal plane, to any outer boundary of the horizontal spacing unit.

The request to deviate from an orthodox location has met all requirements of 19.15.16.15 (C)(5)(a) NMAC. It is understood that you are seeking this exception in order to create a non-standard location, comprised of First and Last Take Points referenced above within the described Horizontal Spacing Unit.

This well's completed interval is 214 feet to the western edge of the horizontal spacing unit. Encroachment will impact the following tracts.

Section 28, encroachment to the E/2 W/2
Section 33, encroachment to the E/2 W/2

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in 19.15.2.7(A)(8) NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands you are seeking this unorthodox location to be the most efficient development of acreage within the Wolfcamp formation underlying the W/2 E/2 Section 28 and the W/2 E/2 (equivalent) Section 33. Thereby preventing waste and protecting correlative rights.

EOG Resources, Inc. ("EOG") (OGRID No. 7377), pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC and applicable rules governing acreage and well location requirements for the WC-025 G-10 S263328C;LWR WOLFCAMP [98417], seeks administrative approval of an unorthodox well location for its Rattlesnake 28 Fed Com 746H well (API No. 30-025-56042), in a 236.92-acre, more or less, spacing unit underlying the W/2 E/2 of Section 28 and NW/4 NE/4 and Lot 2 (W/2 E/2 equivalent) of irregular Section 33, Township 26 South, Range 33 East, NMPM, Lea County, New Mexico.

The location of the **Rattlesnake 28 Fed Com 746H** oil well is as follows:

- Surface location: 1,068' FNL and 2,340' FEL (Unit B) of Section 28
- First take point: 100' FNL and 2,421' FEL (Unit B) of Section 28
- Last take point: 100' FSL and 2,421' FEL (Lot 2) of irregular Section 33
- Bottom hole location: 100' FSL and 2,421' FEL (Lot 2) of irregular Section 33

Since this acreage is governed by state rules for oil wells, the completed lateral of the proposed wellbore is unorthodox because it is located closer than 330' to the western boundary of the spacing unit—thus, encroaching on the tracts to the west comprising the E/2 W/2 of Sections 28 and 33.

EOG respectfully requests administrative approval of a non-standard location for the **Rattlesnake 28 Fed Com 746H**. As explained in the engineering statement included as **Exhibit A**, approval of the unorthodox interval is necessary because EOG's technical team believes it will allow for the most efficient development of this acreage, thereby preventing waste.

Exhibit B is a Form C-102 showing that the lateral of the Rattlesnake 28 Fed Com 746H well encroaches on the tracts to the west, specifically the tracts comprising the E/2 W/2 of Sections 28 and 33.

Exhibit C is a plat for the subject area that shows the Rattlesnake 28 Fed Com 746H well in relation to the offsetting adjoining tracts to the west, operated by EOG, which include leased federal tracts, as explained by the landman statement attached. Accordingly, the "affected persons" are the Bureau of Land Management ("BLM") and the following working interest owners: Ellipsis Oil & Gas, Inc., Lapetco, Inc., and Chief Capital (O&G) II LLC.
