Ascent and Marathon have been negotiating and trying to resolve contested cases 16321, 16322, 16323, 16232, 16233, 16409 and 16410, which are set for the September 20 docket. On Friday Ascent sent Marathon a proposal and Marathon is rushing to review that proposal with management now, but likely will not have a response from management by this Thursday's docket. While both parties would like to move these cases along, Marathon believes that a continuance to the October 4th docket is necessary and in order to see if a special docket hearing can be avoided.
