Dear Ms. Davidson,

As you know, Hilcorp Energy has applied to the New Mexico Oil Conservation Commission to do double drilling of Mesa Verde gas wells in San Juan and Rio Arriba Counties. This would essentially cut well spacing in half -cutting drilling spacing from 80 acres per well to 40 acres per well. This could amount to 7500 wells!!

If this request is accepted, there will be no future opportunity for the public to participate in spacing decisions throughout these two counties. This is how the oil and gas industry slowly and quietly erodes community protections from extraction.

Because fossil fuels are on they way to being replaced by renewable energies, this would be particularly destructive. There are sufficient wells to cover the transition. We don not need to double down on well sites.

Dear Florene Davidson:

I'm writing because I have read that a decision is in the works that could double the number of wells in a given area of San Juan and Rio Arriba Counties.

The proposal is not widely known by the public, which is concerning to me. How can the New Mexico Oil Conservation Committee make an informed decision without detailed and thoughtful input from local residents and from those who study the impacts on the land, the people, and the ecosystem of increased density of drilling? This kind of wholesale change in how much oil drilling is to be permitted should have far more input than the proposed hearing tomorrow will allow.

My public-health background informs my opinion that there are many important issues to consider, including the effects of a greater density of wells on air and water quality and on the existing rights of ranchers, Native American communities, and others to use land in the area. I urge you to consider the proposal by Hilcorp Energy Corporation in a manner that accords due process to the interests of the public and particularly those closely connected to the land in this area. This is to say that there should be notice to the public commensurate with the importance of the issues, together with a process for receiving input that is fair, thorough, and open-minded.

Dear Ms. Davidson

I heard that public comments might be heard during the hearing tomorrow. It is such short notice that I will not be able to attend. I hope you will accept my written comments as follows:

September 12, 2018

To: The New Mexico Oil Conservation Commission

According to the September 13, 2018 NMOCD agenda, there is no public comment period. Today, I heard that public comments might be heard. Notice of this meeting was announced by our local papers only a few days ago. This short notice does not allow the impacted citizens nor the environmental organizations time to prepare to attend the hearing or prepare much input. The hearing is being held in Santa Fe. I believe that hearings to address this issue should be conducted in the impacted areas of San Juan and Rio Arriba Counties. Where is the transparency and regard for the impacted people under the current environmental conditions?

Yes, I stated "impacted people". Those of us who live near gas wells are subjected to toxic emissions from these facilities 24 hours every day. There are a reported 35,000 or more gas and oil wells in the San Juan Basin Area in San Juan County, Rio Arriba Counties in New Mexico and La Plata County, Colorado. Toxic emissions have no boundaries. Many of these 35,000 gas wells are Blanco-Mesa Verde formation wells.

My family and I live in the San Juan Basin in San Juan County, NM. Our home is in the small town of Aztec, NM. We live in the east side of town. Our neighborhood is adjacent to BLM lands. A recent survey was conducted by a reliable organization that mapped 25 gas wells within a mile radius of our Aztec home! Some of these nearby gas wells are Hilcorp owned Mesa Verde formation wells. 9 active gas wells are within less than a half mile from our home. We are constantly exposed to toxic emissions including neurotoxic and potentially deadly hydrogen sulfide. A recent memo from BLM stated that there are gas wells that contain 1,500 ppm hydrogen sulfide near our home! A BLM map shows more than 325 hydrogen sulfide contaminated wells in the San Juan Basin. That map is several years old. The hydrogen sulfide presence in the gas wells in our area should be a serious consideration in this decision.

I am sure you all are aware of the Methane Hot Spot Cloud that hovers over our area. As far as I know, not much has been done to mitigate the methane emitted by the oil and gas facilities even though claims have been made that methane has been reduced. The proposed additional Hilcorp production will add to the methane emissions in our area.

Our area has been designated as an Extreme Drought Area where water is in very short supply. We are under serious water restrictions in Aztec and Farmington. Our Aztec neighborhood irrigation ditch

Hilcorp Energy Company's proposal to decrease drill spacing from 80 acres per gas well to 40 acres per well could easily result in an additional 7,500 wells appearing in San Juan and Rio Arriba counties. I find it hard to understand how such an increase can be contemplated, given the fact that impacts on air quality, water, and landscapes in northern New Mexico have not been calculated. The population of ranchers, tribal communities, and other residents living in this area would certainly be affected, not just because water may become unusable but because increased truck traffic and other results of this massive increase in drilling will make other beneficial uses of the land so much more difficult. I remember that part of this region was once named an Area of National Sacrifice by a national science foundation almost three generations ago.

It appears that the only public notice of the proposal was a legal notice in San Juan and Rio Arriba county newspapers, and that happened with only three weeks before the hearing began. Clearly there has not been enough time for the general public as well as the people more closely related to this level of development to understand and respond constructively to the proposal.

These wells have not been planned for and their impacts have not been addressed. I think it is essential for the public, including especially those most likely to be directly impacted, to have time to assess the proposal and, if need be, effectively oppose it.

Dear Ms. Riley,

I am writing today to express my extreme opposition to Hilcorp's Application 16403 asking to double drill in the San Juan Basin, asking for this to be a permanent rule and asking to not allow for public input.

You need look no further than the Navajo lands in our northwest to see how devastating increasing the amount of drilling by two would be to the entire area.

There are already 30,000 wells there!

Further, this type of attempted corporate grab is exactly why no one trusts them to do the right thing. With money being their only target, everything else and everyone else can be sacrificed according to Hilcorp.

And by the way have you looked at their operating history? Here's just a brief review for you from DESMOG Blog May 30, 2018:

"Investigative reporting by Inside Climate News and the Revelator discovered that state regulators grew frustrated with Hilcorp to a highly unusual degree. "The disregard for regulatory compliance is endemic to Hilcorp's approach to its Alaska operations and virtually assured the occurrence of this violation," the chair of Alaska's Alaska Oil and Gas Conservation Commission (AOGCC) wrote to the company in November 2015, Inside Climate News found. "Hilcorp's conduct is inexcusable."

"Hilcorp's history of noncompliance and its failure to take the rudimentary measure of entering AOGCC's requirements in its regulatory tracking system preclude any claim that Hilcorp has acted in good faith," said a 2016 state decision fining the company for failing to file required reports.

In Ohio, the oil and gas firm is suspected of causing over 75 earthquakes, due to fracking operations which inject fluids into shale formations to crack open and release the fossil fuels within them. Hilcorp's Louisiana track record includes seven oil spills in just one year, totaling over 23,000 gallons of crude.

The feds fined Hilcorp for five Clean Air Act violations in Pennsylvania between 2014 and 2015. The following year, the U.S. Pipeline and Hazardous Materials Safety Administration discovered an array of safety violations, "including failure to inspect and test gas pipeline main valves and relief valves, failure to follow control-room management procedures and failure to accurately report pipeline flow data," the Revelator reported.

"Every other company seems to get it but Hilcorp," Scott Eustis, coastal wetland specialist for the Gulf Restoration Network, told the Revelator after Hilcorp leased up land used by oystermen after its illegal dredging methods damaged oyster beds. "They are a company whose business model is rip and run, and their acquisition of oyster leases is a plan to pollute."

I urge you, do not approve this Hilcorp Application 16403.

[State will consider boosting gas well density in northern NM](#)

At its meeting on Thursday, September 13, the New Mexico Oil Conservation Committee will hear from an energy company that wants to double the density of gas wells in northwestern New Mexico.

Hilcorp Energy Company is asking the state to amend well density requirements in what's called the Blanco-Mesaverde Gas Pool in San Juan and Rio Arriba counties.

Under the current rules, companies can drill four wells within the designated 320-acre spacing units, and only two can be drilled within each 160-acre section. Companies can also ask the state to increase the density of wells on a case-by-case basis, something Hilcorp notes in its application New Mexico has allowed it to do in 62 instances this year.

Rather than continuing to file individual applications, each with its own public notice and hearing, the company is now asking New Mexico to change the spacing rules for the entire Blanco-Mesaverde pool.

In its application, attorneys for the company point out that the rules adopting the 320-acre units were established in 1949 "on the assumption that one well would adequately drain and develop 320-acres." Over time, the Oil Conservation Division has increased the well density. And the company says it should do so again to "prevent waste and drain unrecovered gas reserves."

The state makes the density rules on all leases, even if they are on federal lands. Then the relevant agency, such as the U.S. Bureau of Land Management, approves or denies applications for permits to drill.

According to the company's application, it currently operates 5,239 wells within the Blanco-Mesaverde Gas Pool.

In 2017, ConocoPhillips [sold its San Juan Basin assets](#) to Hilcorp Energy Company. Earlier this summer, the [Houston Chronicle](#) reported that an affiliate of Hilcorp, Harvest Midstream, was buying gas pipeline and processing facilities in the San Juan from Williams Partners. That \$1.1 billion sale included more than 3,700 miles of pipeline, two gas processing plants and one carbon dioxide treatment facility.

Group calls for state to delay decision

Mike Eisenfeld of the San Juan Citizens Alliance was one of the people who spotted Hilcorp's legal notice in the back of *The Farmington Daily Times* on August 23 and 24. He said that the change could mean up to 7,500 new wells in the two counties.

Eisenfeld's group wants the state to delay its decision and have "more active and robust hearings" on the change. They're planning to file a request for a continuance, or deferral, at Thursday's meeting. That would allow interested parties to prepare an intervention or provide testimony on issues such as environmental impacts, he explained, and also give residents and landowners more time to plan to attend the hearing in Santa Fe.

Although the rule change would apply to only two counties, Eisenfeld thinks it could have larger implications.

"This would be a major rule-making and would open to the door to all sorts of formations [in addition to the Blanco-Mesaverde pool]," Eisenfeld said. "It would slaughter the places that have oil and gas."

One local landowner, Don Schreiber, is worried the Oil Conservation Commission will approve the change.

"If it's two wells per 640 acres, as it was originally, then we're talking multiple use," he said, referring to a mandate for public lands, which allows for various uses on one plot of land, whether that's oil and gas drilling, livestock grazing, recreation or other uses. "If it is 16 wells per 640 acres as is proposed, then we're talking an 11,000-square mile industrial zone."

He also called the timing of the request a "last-ditch, lame-duck gift to industry by two ex-oil company executives as they leave."

Two top officials with the New Mexico Energy, Minerals and Natural Resources Department came to state service from the oil and gas industry. Secretary Ken McQueen retired as San Juan vice president from WPX Energy shortly before his appointment by Gov. Susana Martinez in late 2016. WPX Energy is a subsidiary of [Williams Companies](#). The current director of the Oil Conservation Division is Heather Riley, who was formerly WPX's senior regulatory specialist in New Mexico.

"On their way out the door, McQueen and Riley are trying to make another big payoff to the oil industry; doubling the drilling in the majority of the San Juan Basin and forever removing New Mexico citizens, or their federal representatives, from participating in the critical process of determining just how many wells an oil company can drill," said Schreiber, who owns a ranch in the area and has been a vocal opponent of increased drilling.

When asked if the commission will issue a decision at Thursday's meeting or just collect information about the application, a spokesperson for the department pointed out that the agenda states the "hearing may continue to following days if not completed." If the hearing is completed, the commission "may deliberate at the end of the hearing," she said.

Meanwhile, in southern New Mexico earlier this week, the U.S. Bureau of Land Management conducted an online lease sale of 142 parcels. The sale revenues totaled \$972,483,619.50.

Thursday morning, the U.S. Department of the Interior issued a [press release](#), about the record-breaking lease sale, which the department called a "testament to the Trump Administration's America First Energy Plan."

The release also included a statement from Interior Secretary Ryan Zinke: "Critics of the Administration's American Energy Dominance policy often falsely claim there is little to no interest in Federal oil and gas leases," he said. "Today they are eating their words and once again President Trump's policies are bearing fruit for the American people. The people of New Mexico will see about a half a billion dollars of this right back into their roads, schools and public services."

The Oil Conservation Commission hearing is [scheduled](#) for 9 a.m. on September 13 at the Wendell Chino Building in Santa Fe.

And by the way have you looked at their operating history? Here's just a brief review for you from DESMOG Blog May 30, 2018:

"Investigative reporting by Inside Climate News and the Revelator discovered that state regulators grew frustrated with Hilcorp to a highly unusual degree. "The disregard for regulatory compliance is endemic to Hilcorp's approach to its Alaska operations and virtually assured the occurrence of this violation," the chair of Alaska's Alaska Oil and Gas Conservation Commission (AOGCC) wrote to the company in November 2015, Inside Climate News found. "Hilcorp's conduct is inexcusable."

"Hilcorp's history of noncompliance and its failure to take the rudimentary measure of entering AOGCC's requirements in its regulatory tracking system preclude any claim that Hilcorp has acted in good faith," said a 2016 state decision fining the company for failing to file required reports.

In Ohio, the oil and gas firm is suspected of causing over 75 earthquakes, due to fracking operations which inject fluids into shale formations to crack open and release the fossil fuels within them. Hilcorp's Louisiana track record includes seven oil spills in just one year, totaling over 23,000 gallons of crude.

The feds fined Hilcorp for five Clean Air Act violations in Pennsylvania between 2014 and 2015. The following year, the U.S. Pipeline and Hazardous Materials Safety Administration discovered an array of safety violations, "including failure to inspect and test gas pipeline main valves and relief valves, failure to follow control-room management procedures and failure to accurately report pipeline flow data," the Revelator reported.

"Every other company seems to get it but Hilcorp," Scott Eustis, coastal wetland specialist for the Gulf Restoration Network, told the Revelator after Hilcorp leased up land used by oystermen after its illegal dredging methods damaged oyster beds. "They are a company whose business model is rip and run, and their acquisition of oyster leases is a plan to pollute."

As you know, Hilcorp Energy has applied to the New Mexico Oil Conservation Commission to do double drilling of Mesa Verde gas wells in San Juan and Rio Arriba Counties. This would essentially cut well spacing in half -cutting drilling spacing from 80 acres per well to 40 acres per well. This could amount to 7500 wells!!

If this request is accepted, there will be no future opportunity for the public to participate in spacing decisions throughout these two counties. This is how the oil and gas industry slowly and quietly erodes community protections from extraction.

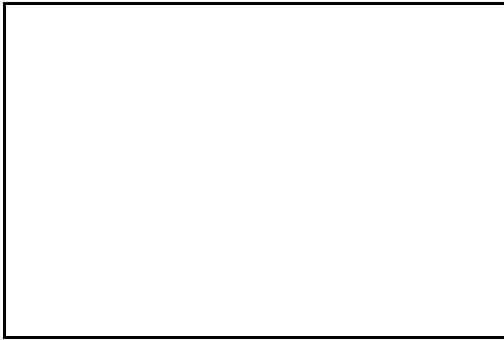
Because fossil fuels are on they way to being replaced by renewable energies, this would be particularly destructive. There are sufficient wells to cover the transition. We don not need to double down on well sites.

Important facts:

- Hilcorp Energy Company's application in Case 16403 could result in thousands of more wells being drilled in northern New Mexico. These additional wells have not been planned for and their potential impacts have not been assessed. More drilling in this landscape could lead to enormous and detrimental environmental, public health, and social impacts.
- The cumulative impacts of potential additional wells made possible by this application could have devastating effects on air quality, water, and landscapes in northern New Mexico. Ranchers, tribal communities, and other residents living in the area could be deeply affected by additional wells and by increased truck traffic.
- If granted, this application would effectively shut out the public from further participation in decisions about well spacing for Mesaverde wells in San Juan and Rio Arriba Counties.
- The public has not been sufficiently notified of this proposal, and has not had the time to respond to it. An application with the potential to have such significant impacts in northern New Mexico, and that would effectively close the door to further public input about Mesaverde wells, needs to be brought to the full attention of the public. However, the public was only notified of this proposal through an obscure legal notice in newspapers in San Juan and Rio Arriba Counties on August 23, only three weeks before the hearing. This does not allow enough time for the public to consider the issues at stake and provide comments to the New Mexico Oil Conservation Commission about Hilcorp's application.
