1 HEARING EXAMINER COSS: I would now like to call

- 2 Case Number 20933, Black Water Management for SWD
- 3 application.
- 4 MR. RANKIN: Good morning, Mr. Examiner. May it
- 5 please the Division. I have exhibit packets for you all.
- 6 HEARING EXAMINER COSS: Are there any other
- 7 entries of appearance for this case?
- 8 (No response.)
- 9 HEARING EXAMINER COSS: You may proceed.
- 10 MR. RANKIN: Mr. Examiner, Adam Rankin on behalf
- 11 of the applicant in this case, Black River Water Management
- 12 Company of the law office of Holland & Hart. We will be
- 13 presenting this case by affidavit.
- Mr. Examiner, before you is an exhibit packet
- 15 containing three exhibits of the affidavits of three of
- 16 Black River's witnesses.
- 17 The first affidavit is of Mr. Marshall Brooks
- 18 Verschoyle. He is the landman and previously testified
- 19 before the Division.
- 20 In this case Black River Water Management is
- 21 seeking an increase in tubing size in its existing,
- 22 currently injecting Malaga SWD Number 4 well. Current
- 23 tubing in the injection well is 4.5 inches. They are
- 24 seeking an increase to 5.5 inches.
- They have provided notice to all interest owners

- 1 affected parties within a one mile area of review
- 2 surrounding the well. Mr. Verschoyle testifies to the
- 3 effort he has undertaken to to identify the interest owners.
- 4 And attached to his affidavit is a copy of the notice that
- 5 was sent out to each of the affected parties within the one
- 6 mile area of review, as well as the demonstration of
- 7 certified mailing, and a notice of publication reflecting
- 8 the notice was provided in the newspaper within the county
- 9 where the well is located.
- 10 Exhibit B is a copy of the affidavit of
- 11 Dr. Edmund Locke Frost III. He conducted an updated fault
- 12 slip analysis analyzing the effect of the increased tubing
- 13 and the higher volumes and rate as a result. He identifies
- 14 that there is no significant risk of fault slip potential as
- 15 a result of the increased volume of rates of injection.
- 16 Attached to his exhibit is a model study that he prepared
- 17 reflecting his analyses.
- 18 Exhibit C is an affidavit prepared by Mr. Brad
- 19 Robinson who is Malaga's petroleum engineer. Mr. Robinson
- 20 conducted a study of the effects of the increased tubing
- 21 size and reviews his analysis of the results of his -- of
- 22 the study that he conducted on the potential impact of the
- 23 increased tubing size.
- In addition, in response to the Division's
- 25 request, Mr. Robinson has also prepared a proposed study of

1 the -- rather, the proposed plan for plugging and abandoning

- 2 the well as well, so he's got a draft or proposed wellbore
- 3 design for a plugging and abandoning the plan going forward,
- 4 as well as a written narrative plan on the Division's
- 5 request, so that also is attached as an exhibit to his
- 6 affidavit.
- With that I would ask that Exhibit A, B and C be
- 8 taken -- accepted into the record, and that the case be
- 9 taken under advisement.
- 10 (Exhibits A, B and C offered.)
- 11 HEARING EXAMINER COSS: My only question, is it
- 12 just an increase in tubing size or increase in injection
- 13 volume as well?
- MR. RANKIN: Well, as a result of the tubing
- 15 increase there will be an increase in volume, but under the
- 16 existing order there is no limitation on the volume, so it
- 17 would be under the limitation here is the surface injection
- 18 pressure and that won't change. So the only requested
- 19 change is the tubing size.
- 20 HEARING EXAMINER COSS: I see. Thank you for
- 21 that additional information, and with that I will take case
- 22 Number 20933 under advisement.
- MR. RANKIN: Thank you very much.
- 24 (Case 20933 taken under advisement. Adjourned.)
