- 3 compulsory pooling.
- 4 MS. BENNETT: Good morning, Mr. Examiners. My
- 5 name is Deana Bennett from Modrall Sperling on behalf of
- 6 Franklin Mountain Energy LLC. To my knowledge there are no
- 7 other entries of appearance in this case -- these cases.
- 8 HEARING EXAMINER COSS: Is that statement
- 9 correct? Are there any other other entries of appearance
- 10 into these cases?
- 11 (No response.)
- 12 HEARING EXAMINER COSS: You may proceed.
- MS. BENNETT: I intend to put these cases on by
- 14 affidavit as well.
- 15 HEARING EXAMINER COSS: You may proceed.
- 16 MS. BENNETT: Thank you. The packet I handed to
- 17 you is a packet of materials for Case 20952 and 20953 in
- 18 which Franklin Mountain Energy seeks compulsory pooling.
- 19 And these cases both involve horizontal spacing
- 20 units that target the Wolfcamp formation. Again, between
- 21 these two cases they cover the W/2 of Sections 2 and 11,
- 22 Township 25 South, Range 35 East, Lea County, New Mexico.
- I should point out that these three cases that I
- 24 just discussed are part of a larger development plan that
- 25 Franklin Mountain Energy is proposing, and the other three

1 cases that will be covering the east half of these sections

- 2 are set for hearing on January 9, 2020.
- 3 Behind Tab 8 is my affidavit of notice, and again
- 4 it includes an affidavit stating that notice was mailed out
- 5 to the affected parties. It includes the status of those
- 6 mailings, and it also includes the photocopy from the e-mail
- 7 from the affidavit of publication. Same situation applies
- 8 here, here with respect to the publication issue that I
- 9 discussed earlier.
- 10 One of the things I would mention in terms of
- 11 the, as you are considering the notice issue, is that for a
- 12 number of the folks that we identified or that Franklin
- 13 Mountain identified, we had sometimes up to five or six
- 14 different addresses, and you will see that we sent letters
- 15 to each of those address. And although one letter may not
- 16 have been delivered to a particular address, the other three
- or four letters were delivered, so -- and I can assure you,
- 18 based on my own experience over the last ten days, that my
- 19 letter were received by various individuals, having been
- 20 contacted by a number of parties to whom I sent letters.
- 21 So with that I would ask that Exhibits A and B and their
- 22 attachments be admitted into the record for Case Number
- 23 20952 and and Case Number 20953.
- 24 HEARING EXAMINER COSS: The exhibits will be
- 25 admitted into the record, and Case Numbers 20952 and 20953
