1 HEARING EXAMINER COSS: Let's begin the hearing

- 2 this morning. It's 8:19, January 9, 2020, and we will begin
- 3 with the OCD Hearing Docket Number 02-20. And just to get
- 4 things started, I believe Kathleen Murphy has a few
- 5 announcements for us, so take it away.
- 6 MS. MURPHY: I have just a few announcements, and
- 7 they are good announcements. I like to announce if it's
- 8 good or bad to begin with, but we do have three new
- 9 employees, and the first one is -- Cox, and he has a
- 10 bachelor's in petroleum engineering from New Mexico Tech.
- 11 He also has a lot of experience in software engineering and
- 12 computer science experience. He worked as a superintendent
- 13 for fracking and leasing operations with Calfrac, and he is
- 14 our administrative permits coordinator, and we welcome him.
- 15 Another new employee is Kurt Simons in the back.
- 16 Kurt has a juris doctorate and is licensed in California.
- 17 And he worked for the BLM in Carlsbad for eight years as a
- 18 legal instrument examiner, permitting oil and gas wells on
- 19 federal land.
- 20 And our third employee is Don Garcia. He has a
- 21 bachelor's in petroleum engineering and a master's in
- 22 mechanical engineering also from New Mexico Tech. He was a
- 23 field engineer for Calfrac for a year and a half, and he
- 24 interned at the OCD in 2015 and worked in UIC and also did
- 25 some work on --

- 1 So we are very excited to have three new
- 2 employees, and we appreciate that they have chosen OCD. And
- 3 we have a lot of work, and we are starting to send them on a
- 4 certain path.
- 5 MS. MUNDS-DRY: What are their titles?
- 6 MS. MURPHY: In Mr. Cox is permits coordinator;
- 7 is that correct?
- 8 MR. COX: Yes.
- 9 MS. MURPHY: Mr. Simons and Mr. Garcia are
- 10 petroleum specialists.
- MS. MUNDS-DRY: Thank you.
- MS. MURPHY: The next topic is the exhibits, and
- 13 I believe I give the same talk on exhibits because the
- 14 exhibits are what you submit to the court reporter and to
- 15 the Examiner. But I always say this in case there is new
- 16 lawyers, you need to e-mail your PDF of the exhibits to the
- 17 OCD hearings e-mail and put "exhibits" in the title line,
- 18 and then in the actual PDF document, make sure the case file
- 19 number is in there.
- 20 Sometimes people send the document named scanned
- 21 from whatever scanner, and I want you to name it so I don't
- 22 have to do extra work when I download it.
- 23 MR. AMES: You might put out there's a notice on
- OCD's website that details the procedures specifically.
- MS. MURPHY: On the OCD website, you have noticed

- 1 this up there, and the exhibits -- the checklist for
- 2 compulsory pooling, we have a blank exhibit up there, and we
- 3 also have a filled-in exhibit, and you have noticed those on
- 4 there, and that's how compulsory pooling will be done from
- 5 now on.
- 6 And so two copies of your exhibits and two copies
- 7 of the checklist. You come up and essentially just lay it
- 8 down and say that it's complete, and we move on.
- 9 And because -- because of the new checklist, the
- 10 Exhibit A will not be needed anymore. The checklist takes
- 11 the place of Exhibit A. Please only use PDF. We don't want
- 12 jpegs or PowerPoints. You can export in this those programs
- 13 to a PDF.
- 14 And are there any questions on the new compulsory
- 15 pooling checklist? There was a notice on the website, and
- 16 also Ms. Davidson sent out an e-mail to all the lawyers.
- 17 And we will just have to start seeing how that goes along.
- 18 We need to begin somewhere.
- 19 And the last topic was, that I have for you, is
- 20 the technology and using the TV screen to do presentations.
- 21 As a rule of thumb, if your presentation is longer than 10
- 22 to 15 minutes, if it is controversial, or if it is of
- 23 interest to the public, it should be presented using the TV
- 24 screen.
- 25 And OCD frequently has presentations using the

- 1 screen, so why not us. And it's not to add work for you.
- 2 You use the existing PDF that you then e-mail to OCD
- 3 hearings, and you don't have to make extra PowerPoints or
- 4 anything.
- 5 And it's a tremendous educational opportunity
- 6 that we are losing out on, and it's also an opportunity to
- 7 educate the public when there are controversial subjects
- 8 here. And this is all public data, so nothing is being let
- 9 out that should not be. And I will hold up a fine example,
- 10 Mr. Adam Rankin for his final presentation for EOC in
- 11 December. Thank you.
- 12 And we need to start somewhere, and it will only
- 13 get easier over time, and because the compulsory pooling
- 14 checklist does say this sometimes, it will get smoother as
- 15 we go along, but I will say to you, we need to lead and
- 16 others will follow.
- 17 And here's my only suggestion to you. Please
- 18 watch your colleagues as they present and learn from them.
- 19 You can bring your own laptop and use two PDFs. You can
- 20 have the entire PDF that you then submit to OCD hearings and
- 21 the court reporter, and you can make a subset of it and use,
- 22 you know, 10 to 15 pertinent slides that you will present.
- 23 If there's follow-up questions, you will have the entire PDF
- 24 open and you can refer to that.
- 25 If I can help you in any way, please let me know

1 if you want to do a dry run during the week or come in., We

- 2 can meet and go over this. I'm very willing to help. And
- 3 are there any questions on using this?
- 4 (No response.)
- 5 MS. MURPHY: Thank you in advance to any of those
- 6 who are using it today.
- 7 And then the last topic is, we do have a map over
- 8 here which is the saltwater disposal applications, and it
- 9 comes from our Excel table of all the applications, and this
- 10 way you can see it graphically represented, and all the reds
- 11 are the protested applications, and there is also the potash
- 12 area in the middle. So it's an interesting map.
- 13 And are there any questions on any of these
- 14 topics?
- MS. SHEEHAN: Is that map available on the
- 16 website?
- 17 MS. MURPHY: It's not, but there -- at this
- 18 moment, but we do have a GIS map that is available to the
- 19 public, and I believe that maybe within a week we might have
- 20 the -- the polygon for the applications on that.
- 21 MR. AMES: Thank you, Kathleen. Before Dylan
- 22 takes over, I would like to make an announcement. It's
- 23 OCD's great pleasure to have with us today Felicia Orth.
- 24 Felicia is an experienced attorney and a very experienced
- 25 hearing examiner.

1 She's worked for the Environment Department, City

- of Albuquerque, Air Quality Board, a number of other
- 3 agencies both in-house and on contract. She'll be assisting
- 4 OCD with these hearings going forward at some point. Today
- 5 she is observing, but at some point she'll take over as
- 6 well, so we are very pleased and happy to have her aboard.
- 7 MS. ORTH: Thank you.
- 8 HEARING EXAMINER COSS: So at this time I'm going
- 9 to read the dismissed cases for today.
- The first case is WPX Energy Permian, Case 20991;
- 11 followed by Mewbourne Oil Company, compulsory pooling, Case
- 12 21003; and Mewbourne Oil Company, Case Number 21004; and
- 13 Kaiser-Francis Oil Company, Case Number 21007 are all the
- 14 cases that have been dismissed from this docket.
- 15 The continued cases include for these cases have
- been continued to the January 23, 2020 docket.
- 17 Application of XTO Delaware Basin LLC, Case
- 18 Number 20918; and application of XTO Delaware Basin, Case
- 19 20919 have been continued to the January 23rd docket.
- The following cases have been continued to the
- 21 February 20, 2020 docket. They include the application of
- 22 Ostrich Oil and Gas LLC, Case Number 20988; application of
- Ostrich Oil and Gas LLC, Case Number 20989; application of
- 24 Cimarex Energy, Case Number 21005; and application of
- 25 Cimarex Energy, Case Number 21006.
