SAVAGE: Darin Savage of Abadie & Schill for 3 4 Devon Energy Production Company, LP. 5 HEARING EXAMINER COSS: Good morning. Are there 6 any additional appearances? 7 MR. HOUGH: Lance Hough on behalf of Cimarex 8 Energy Company. 9 HEARING EXAMINER COSS: Okay. Do you have any --10 oh, good morning. MR. SAVAGE: Good morning. 11 12 HEARING EXAMINER COSS: So I understand that you 13 are intending to present this by affidavit and just a 14 supplemental exhibits. 15 MR. SAVAGE: That is correct.
