1 HEARING EXAMINER COSS: Okay. Moving along, the

- 2 Division would like to call 20979. Call for appearances.
- 3 MS. MUNDS-DRY: Good morning, Mr. Examiner, my
- 4 name is Ocean Munds-Dry. I'm senior counsel at COG
- 5 Operating LLC. And because it's been a while, I'm going to
- 6 give the court reporter my card. We intend to present this
- 7 case by affidavit.
- 8 HEARING EXAMINER COSS: And there is additional
- 9 appearances?
- 10 MR. HOUGH: Yes. Lance Hough from the Modrall
- 11 Sperling Law Firm on behalf of EOG Resources, Inc.
- MS. MUNDS-DRY: Mr. Hearing Examiner, we ask also
- 13 that you call Case 20980 and 20981. We would ask that these
- 14 cases be consolidated for purposes of hearing.
- 15 HEARING EXAMINER COSS: Do you have any
- 16 objections to these cases being presented by affidavit --
- 17 oh, are you entering your appearance in all cases?
- 18 MR. HOUGH: I would like for my entry of
- 19 appearance to apply to all three cases on behalf of EOG
- 20 Resources.
- 21 HEARING EXAMINER COSS: Okay. And do you object
- 22 to the cases being presented by affidavit?
- MR. HOUGH: No objection.
- 24 HEARING EXAMINER COSS: Okay. And so for
- 25 presenting by affidavit, I'm going to make sure that

- 1 everything is in order to do so. And so was notice of
- 2 publication required for unlocatable parties in this case?
- 3 MS. MUNDS-DRY: Mr. Examiner, notice of
- 4 publication was not required, but out of abundance of
- 5 caution we did publish notice.
- 6 HEARING EXAMINER COSS: It was done so timely?
- 7 MS. MUNDS-DRY: Done so timely.
- 8 HEARING EXAMINER COSS: And THERE is an affidavit
- 9 of the publication included in the packet?
- 10 MS. MUNDS-DRY: There is. You will see in
- 11 Exhibit Number 3 there is a notice packet, including my
- 12 affidavit of the notice and evidence of the publication.
- 13 HEARING EXAMINER COSS: Wonderful. Thank you.
- 14 And I happened to open up to Tab 3, which is the compulsory
- 15 pooling checklist.
- 16 MS. MUNDS-DRY: Yeah, Mr. Examiner, we're gonna
- 17 feel this out, and we'll get this right for you, but the tab
- 18 numbers don't -- they correspond to the table of contents
- 19 and not the exhibit numbers, so I apologize if that's
- 20 confusing. We will get this straightened out for you the
- 21 way you would like it as we go along. I promise.
- 22 HEARING EXAMINER COSS: This, so far so good, as
- 23 long as everything is in here and the checklist is included,
- 24 we can continue to hear this by affidavit. And you have
- 25 included tabs and the table of contents.

1 MS. MUNDS-DRY: It's all in there, we just may

- 2 need to perfect the process a little bit, Mr. Examiner.
- 3 HEARING EXAMINER COSS. Perfect. You may proceed
- 4 to submit this case by affidavit.
- 5 MS. MUNDS-DRY: Thank you. You will see the
- 6 table of contents after the cover page and the corresponding
- 7 checklist for each of the cases seeking to pool in Eddy
- 8 County for three wells.
- 9 Also included are affidavits from a landman and a
- 10 geologist. And as I mentioned earlier, our notice packet
- 11 included my affidavits of notice.
- 12 And unless you have any questions, we would ask
- 13 that these, these applications be, and the exhibits, the
- 14 attachments and notice packet be admitted into evidence.
- 15 HEARING EXAMINER COSS: They are so admitted.
- 16 The exhibits will be so admitted.
- 17 (Exhibits 1, 2 and 3 admitted.)
- 18 MS. MUNDS-DRY: Unless you have any questions, we
- 19 would ask that these three cases be taken under advisement.
- 20 HEARING EXAMINER COSS: Currently I do not have
- 21 any questions. I will reach out if I do, but seeing as how
- 22 I don't at the moment, the Division will take --
- MR. HOUGH: Mr. Examiner, I just wanted to add to
- 24 the record that the parties have reached an agreement for
- 25 EOG to have a 90-day period to select.

Page 6 HEARING EXAMINER COSS: Wonderful. Thanks for that, and there is no --MR. HOUGH: No, Mr. Examiner. HEARING EXAMINER COSS: So Case Numbers 20979, 20980 and 20981 will be taken under advisement. (Cases 20979, 20980 and 20981 taken under advisement.) MS. MUNDS-DRY: Thank you, Mr. Examiner. If you do have feedback about how we can do the packet better, please let us know. It's a work in progress. HEARING EXAMINER COSS: I will do so. (Adjourned.)
