21                  HEARING EXAMINER COSS: I see. Did you provide a  
22 compulsory pooling checklist in this packet?

23                  MS. BROGGI: We did. We provided a checklist for  
24 each of the two cases, and you will find them behind Tabs 1  
25 and 2 of the packet before you.

1                   HEARING EXAMINER COSS: Perfect. You may proceed  
2 with your affidavit. Thank you.

3                   MS. BROGGI: Mr. Examiner, before you in the  
4 packet we have an affidavit from the landman with  
5 accompanying exhibits found at Exhibit A, an affidavit from  
6 a geologist with accompanying exhibits as Exhibit B, and  
7 finally Exhibit C is a notice -- an affidavit providing or  
8 asserting that notice was provided to the parties that COG  
9 is seeking to pool in this case.

10                  And so unless you have any questions, we would  
11 ask that Exhibits A, B and C be admitted into the record and  
12 that Case Numbers 20998 and 20999 be taken under advisement.

13                  HEARING EXAMINER COSS: Wonderful. Thank you.  
14 Exhibits A, B and C will be admitted into the record, and  
15 Case Numbers 20998 and 20999 will be taken under advisement.

16                  MS. BROGGI: Thank you very much.
