1 HEARING EXAMINER COSS: So the next cases we have
2 on our docket, the one that we will call presently, is Case
3 Number 21000, Mewbourne Energy for compulsory pooling. Call
4 for appearances.

5 MR. BRUCE: Mr. Examiner, Jim Bruce of Santa Fe
6 representing the applicant and submitting the case by
7 affidavit.

8 HEARING EXAMINER COSS: Are there additional
9 appearances?

10 MR. RANKIN: Mr. Examiner, Adam Rankin with the
11 law firm of Holland & Hart appearing on behalf of MRC.

12 MR. BRUCE: To save a couple of minutes, I would
13 ask that the next two cases be consolidated for hearing.

14 HEARING EXAMINER COSS: Wonderful. Are you
15 intending to be presenting these cases through affidavit,
16 Mr. Bruce?

17 MR. BRUCE: Yes, sir.

18 HEARING EXAMINER COSS: Mr. Rankin, have you
19 entered appearances in all of these?

20 MR. RANKIN: We have, in all three cases.

21 HEARING EXAMINER COSS: All three cases,
22 wonderful. Do you object to the cases being taken by
23 affidavit?

24 MR. RANKIN: No objection.

25 HEARING EXAMINER COSS: Mr. Bruce, for these

1 cases, was notice of publication required for unlocatable
2 persons?

3 MR. BRUCE: Mr. Examiner, I published by notice
4 in case I didn't get a green card back, but everybody
5 received their certified mail.

6 HEARING EXAMINER COSS: Wonderful. And is the
7 compulsory pooling checklist contained?

8 MR. BRUCE: Exhibit 5 within each exhibit packet.

9 HEARING EXAMINER COSS: Perfect. And I can see
10 these are tabbed and double sided to the extent practical.
11 Thank you for that. And we will move forward to hearing
12 these cases.

13 MR. BRUCE: All three cases involve wells within
14 the N/2 of Section 36, and NE/4 of Section 35 of 20 South,
15 28 East. They are all mile and a half laterals.

16 The first case is a proximity tract Wolfcamp well
17 which has 480 acres dedicated to it. The second, 21001,
18 involves the N/2 N/2 of that acreage I just described for a
19 Third Bone Spring test, and the final case, 21002 involves
20 the S/2 N/2 of that acreage for a Third Bone Spring test.
21 Mewbourne intends to co-develop the Third, Lower Third Bone
22 Spring and the Upper Wolfcamp together.

23 And notice was given to everyone, notice was
24 received. There is a publication affidavit in there. The
25 exhibits -- actually the geologic exhibit is the same for

1 all the applications. It covers all the Bone Spring and
2 Wolfcamp, and it does describe the reason for the proximity
3 tracts, and it shows in one of the attachments behind the
4 cross-section the reason for the full development scheme for
5 the section, and you will see why it's being co-developed
6 this way.

7 HEARING EXAMINER COSS: Perfect. I will be
8 curious to review that then.

9 MR. BRUCE: I move the admission of Exhibits 1
10 through 5 in each of the three cases.

11 HEARING EXAMINER COSS: Is there any objection?

12 MR. RANKIN: No objection.

13 HEARING EXAMINER COSS: Exhibits will be so
14 admitted, and Case Numbers 21000, 21001, and 21002 will be
15 taken under advisement.

16 (Exhibits 1 through 5, Cases 21000, 21001, 21002
17 admitted.)

18 (Cases 21000, 21001, 21002 taken under
19 advisement).
