1 HEARING EXAMINER ORTH: Excuse me. So in Advance

- 2 Energy, this is 20827. Ms. Hardy, would that be an
- 3 affidavit case?
- 4 MS. HARDY: That is an affidavit case.
- 5 HEARING EXAMINER ORTH: All right. So, Ms.
- 6 Callahan, you don't have to move anything if you don't want
- 7 to, but I would like to take the affidavit case first.
- 8 And then 20918 and 20919, XTO, Mr. Rankin, is
- 9 that --
- 10 MR. CLOUTIER: Andrew Cloutier on behalf of XTO.
- 11 That's a motion hearing combined, and I think Mr. Bruce and
- 12 I can probably wrap that up in about 15 minutes.
- 13 HEARING EXAMINER ORTH: I see. So that would be
- 14 probably wiser to take before an hour-long witness hearing.
- 15 All right. So let me throw this out as a suggestion, that
- 16 we take this affidavit case, which presumably will be short,
- 17 that we take the motion to dismiss arguments, which will be
- 18 short, and then we turn to the matter, which apparently will
- 19 require an hour for the four witnesses, and we will work in
- 20 the one for you, Ms. Katz.
- MS. KATZ: Thank you.
- 22 HEARING EXAMINER ORTH: All right. So, Ms.
- 23 Hardy.
- MS. HARDY: Thank you.
- 25 HEARING EXAMINER ORTH: Again, this is 20827,

- 1 Advance Energy. And, Ms. Bennett, you are also entering an
- 2 appearance?
- 3 MS. BENNETT: I am entering an appearance on
- 4 behalf of NGL Water Solutions Permian LLC, but I don't
- 5 object to it going by affidavit.
- 6 HEARING EXAMINER ORTH: Thank you for that. Are
- 7 there any other appearances in 20827.
- 8 MS. HARDY: I just have a question before I
- 9 start. Since I'm presenting this by affidavit, would you
- 10 like me to summarize the notice issues or summarize the
- 11 affidavits and the exhibits in the case?
- 12 HEARING EXAMINER ORTH: What is your preference?
- MR. AMES: Notice for sure. Do you want to hear
- 14 anything about the affidavits?
- 15 EXAMINER GOETZE: Let me take a look at the
- 16 exhibits, and as far as notice make it a part of the record
- 17 and as to notice --
- 18 HEARING EXAMINER ORTH: So just the notice first
- 19 if you will.
- MS. HARDY: Sure, thank you.
- 21 So Exhibit Number 1 in the packet before you is
- 22 the affidavit of landman Paul Burdick, and attached to his
- 23 affidavit are the C-108s. And C-108s contain at Pages 20,
- 24 notice of publication of the administrative application, and
- 25 then the return of receipts that were sent to operators --

1 the notices that were sent to operators within one mile of

- 2 the proposed well.
- 3 And then also there another notice of hearing
- 4 provided by my office, and that is attached to the letter as
- 5 Exhibit E to Mr. Burdick's affidavit, and we did receive the
- 6 return from all the parties to whom we sent notice.
- 7 I think that covers the notice issues unless
- 8 anyone has questions.
- 9 HEARING EXAMINER ORTH: Questions? No?
- 10 EXAMINER GOETZE: That's fine. We have in the
- 11 exhibits, as part of our requirements, Page 18 hydrologic
- 12 statement, do we actually have an individual that is signing
- 13 this statement or attesting to it. Advanced Energy Partners
- 14 does not really qualify as an expert. Does the geologist
- 15 or --
- 16 MS. HARDY: Are you talking about the affidavit
- 17 of the geologist, which is provided as Exhibit 3 in the
- 18 packet. And he offers conclusions regarding the C-108 in
- 19 the hydrogeological testing, if you look at Paragraph 11, 12
- 20 of the affidavit.
- 21 EXAMINER GOETZE: Okay. So it is my
- 22 understanding, back to notification area of review, you did
- 23 a one-half mile radius?
- 24 MS. HARDY: So Mr. Burdick's affidavit states
- owners and operators within one mile were noticed.

Page 6 EXAMINER GOETZE: Very good. And at this time 1 2. Advance Energy is not going to provide any type of, of seismicity? 3 MS. HARDY: There is a seismicity analysis 4 actually, and that is attached to the geologist exhibit, 5 Exhibit Number 3, and the seismic data is, I believe, it's 6 7 Exhibit B -- C and D to that affidavit. So there was a --8 some seismic 3D modeling considered, so yes. 9 EXAMINER GOETZE: Very good. I have no further 10 questions. Thank you. 11 HEARING EXAMINER ORTH: Anything, Mr. Ames? 12 MR. AMES: No, ma'am. Thank you. 13 HEARING EXAMINER ORTH: Thank you very much, Ms. 14 Hardy. Your packet is accepted and the matter will be taken under advisement. 15 16 MS. HARDY: Thank you very much.
