1 HEARING EXAMINER ORTH: All right. Like to call
2 then the case Number 20966, applicant Kaiser-Francis. This
3 is a compulsory pooling matter. Call for appearances,
4 please.

5 MR. BRUCE: Jim Bruce of Santa Fe representing
6 the applicant. I'm submitting the case by affidavit.

7 HEARING EXAMINER ORTH: Are there any other
8 appearances?

9 MR. FELDEWERT: Michael Feldewert of the Santa Fe
10 office of Holland & Hart appearing on behalf of COG
11 Operating.

12 HEARING EXAMINER ORTH: Okay.

13 MS. HARDY: Dana Hardy with the Santa Fe office
14 of Hinkle Shanor for WTG Exploration and BTA Oil Producers.

15 HEARING EXAMINER ORTH: Thank you. First, Mr.
16 Bruce, would you intend to consolidate 20966 with 20967 and
17 20968?

18 MR. BRUCE: Let's do this one alone and then
19 combine the other two.

20 HEARING EXAMINER ORTH: Okay. As I understand
21 it, you propose to submit it by affidavit. Are there this
22 objections, Mr. Feldewert or Ms. Hardy, to submit by
23 affidavit?

24 MR. FELDEWERT: No objection.

25 MS. HARDY: No objection.

1 HEARING EXAMINER ORTH: Mr. Bruce, please go
2 ahead.

3 MR. BRUCE: In this case Kaiser-Francis Oil
4 Company seeks to pool the W/2 of 31, 25 South, 33 East, and
5 W/2 of 6 in 26 South, 33 East, below the top of the First
6 Bone Spring Sand for a two mile Bone Spring -- a number of
7 two-mile Bone Spring laterals.

8 The notice is complete in this matter. Affidavit
9 of publication -- I have one, but everybody received actual
10 certified notice, so that's not included.

11 Two things, I apologize, I, late last night, I
12 ran out of tabs so I don't have tabs on all of the exhibits,
13 but I do to give to the Examiners.

14 HEARING EXAMINER ORTH: All right. So in this
15 matter, as in any others by affidavit, I only want to
16 confirm compliance with the notice requirements. A request
17 for admission of the application affidavit in exhibit -- no
18 description of the exhibit, no detailed description of the
19 exhibits is necessary.

20 MR. AMES: Mr. Bruce, where is the checklist?

21 MR. BRUCE: Sitting in a friend's car where I
22 left it last night. I will e-mail those to the Division
23 today, later today when I e-mail the exhibits.

24 MR. AMES: Okay.

25 HEARING EXAMINER ORTH: Do we accept packets

1 without a checklist?

2 MR. AMES: No, we don't accept packets without
3 the checklist.

4 HEARING EXAMINER ORTH: Would the best course of
5 action be to continue this for two weeks?

6 MR. AMES: I think so.

7 HEARING EXAMINER ORTH: Mr. Bruce, the next time
8 we are together in this room is February 6. Are you
9 available February 6?

10 MR. BRUCE: Yes.

11 HEARING EXAMINER ORTH: All right.

12 If you would please, I will continue this matter
13 to February 6 so that we have a complete application. Thank
14 you. And we can give these back to you.

15 MR. BRUCE: Okay.

16 HEARING EXAMINER ORTH: What about 67 and 68?

17 MR. BRUCE: The story is the same. I would just
18 like to make a brief presentation so the next time I can
19 just submit the exhibits.

20 HEARING EXAMINER ORTH: I believe the new
21 protocol for the Division is to have a presentation made all
22 at once rather than across two different, but thank you.

23 MR. BRUCE: Thank you.
