- 19 geologist's affidavit is common for all of these cases, but
- 20 I did include it in each case file. And there is an
- 21 affidavit of publication, although just this morning I got
- 22 the final green cards in, so everybody received total
- 23 notice, complete notice of this hearing.
- 24 And the only comment I have is that Sharon
- 25 Shaheen entered an appearance for Strata Production Company,
