1 HEARING EXAMINER ORTH: Let's prepare to begin,

- 2 please. All righty. Good morning. My name is Felicia
- 3 Orth. I'm the hearing officer appointed by the director of
- 4 the Oil Conservation Division to conduct hearings this
- 5 morning.
- 6 Please look on the back table -- and by the way,
- 7 we did begin about ten minutes late as a result of the
- 8 traffic snarl related to the accident down the street. And
- 9 if there is someone who should be here who is not here,
- 10 please let me know when we get to the case that involves
- 11 them.
- 12 On the back table you will find the complete
- 13 docket prepared by Marlene Saavedra. These are the cases
- 14 that have been continued, dismissed, et cetera. This is the
- 15 document that you would be looking at if you would like to
- 16 see the cases that we will be calling this morning or today
- 17 and the order in which -- at least roughly the order in
- 18 which I will be calling them.
- 19 I followed up with Mr. Rankin, and we will just
- 20 switch the order of 15 and 17, but that's because one of
- 21 them will have a witness and one of them won't, so we will
- 22 take the ones that don't involve witnesses first.
- 23 So as you can see here, we have 14 matters. The
- 24 first 14 matters involve an update which is essentially a
- 25 status conference. I will call the first set of them first.

- 2 Marathon applications are below that.

- 4 matters on the full docket which, as I understand it, are
- 5 competing claims with the 14 you see there. Their numbers
- 6 are 20374 and 20375, I believe they should be part of this
- 7 update, if I understand correctly.
- 8 MS. LUCK: Katelyn Luck with the Santa Fe office
- 9 of Holland & Hart on behalf of WPX Resources, and those two
- 10 cases, 20374 and 20375, and these two cases we are no longer
- 11 competing with the still pending Ridge Runner and Marathon
- 12 cases because they involve acreage. Those other
- 13 applications have been dismissed and refiled, so that's why
- 14 we have asked to continue the WPX cases.
- 15 HEARING EXAMINER ORTH: To a subsequent hearing
- 16 date?
- 17 MS. LUCK: To a separate hearing date, and then
- 18 we will proceed with the pooling on those two cases
- 19 separately.
- 20 HEARING EXAMINER ORTH: All right. Thank you
- 21 very much. All right. And the other thing is, I do have a
- 22 couple of draft prehearing orders, and we would like to make
- 23 sure that, as you make your appearances and give the update,
- that we are on the same page around what will be expected
- 25 once these prehearing orders are entered. But we will get
