OPPOSED MOTION FOR CONTINUANCE

Applicant V-F PETROLEUM INC. (“V-F Petroleum”) requests that hearing in the above-referenced applications be continued to **May 28, 2020**. This Motion is opposed by Centennial Resource Production, LLC (“Centennial”).

V-F Petroleum understands that Centennial seeks a virtual hearing on these competing proposals, as contemplated by the Division’s April 22, 2020 Notice, Oil Conservation Division’s Instructions for April 30, 2020 Hearing Docket (“Notice”). However, V-F does not consent to a virtual hearing on the competing applications at this time, as it is not prepared to present its witnesses in the audio and visual formats, as required by the Notice. Moreover, the Notice requires the parties to submit a joint stipulation prior to holding a status conference and setting a virtual hearing date. Centennial has made no effort to reach a stipulation with V-F Petroleum.

WHEREFORE, V-F requests that the Division continue these cases to May 28, 2020.
