1 HEARING EXAMINER ORTH: Let's move then to the

- 2 next matter -- or, excuse me, matters, 20374 and 20375, WPX
- 3 Energy, compulsory pooling matters related to the well
- 4 Golden 35, and one is the well Retriever.
- 5 Is there someone here from Holland & Hart on
- 6 behalf of the applicant?
- 7 MS. LUCK: Good morning, Madam Examiner, Kaitlyn
- 8 Luck from the Santa Fe office of Holland & Hart on behalf of
- 9 WPX Permian LLC.
- 10 HEARING EXAMINER ORTH: Thank you. Ms. Bradfute,
- 11 are you here for Marathon?
- 12 MS. BRADFUTE: Yes, Madam Examiner, I am.
- 13 HEARING EXAMINER ORTH: Thank you. Is there
- 14 anyone here on behalf of --
- 15 (No response.)
- 16 HEARING EXAMINER ORTH: No? Is there any other
- 17 appearance at all?
- 18 MR. BRUCE: Madam Examiner, this is Jim Bruce.
- 19 I'm entering an appearance in support of WPX on behalf of
- 20 Burnett Oil Company, and Fortson Oil Company -- that's
- 21 F-o-r-t-s-o-n -- and Novo Oil & Gas Northern Delaware LLC.
- 22 They are working interest in the units with WPX.
- 23 HEARING EXAMINER ORTH: All right. Thank you
- 24 Mr. Bruce. And is there anyone else?
- 25 (No response.)

1 HEARING EXAMINER ORTH: So will this be a

- 2 presentation by affidavit, or are we having a status
- 3 conference on these matters? Ms. Luck?
- 4 MS. LUCK: Thank you. WPX requested to present
- 5 this case by -- or both of these cases by affidavit because
- 6 they no longer compete with Marathon, and so --
- 7 HEARING EXAMINER ORTH: Ms. Luck, we are having
- 8 trouble hearing you. Could you speak up?
- 9 MS. LUCK: WPX requested to present the cases by
- 10 affidavit because they no longer compete with Marathon
- 11 competing cases, and those cases were discussed as a status
- 12 conference on February 20.
- 13 MS. BRADFUTE: Madam Examiner, this is Jennifer
- 14 Bradfute on behalf of Marathon. Marathon has no objection
- 15 to WPX putting these cases on by affidavit.
- 16 HEARING EXAMINER ORTH: All right, thank you.
- 17 Mr. Bruce?
- 18 MR. BRUCE: No objection.
- 19 HEARING EXAMINER ORTH: All right. Thank you
- 20 very much. Ms. Luck, then if you would proceed.
- 21 MS. LUCK: Thank you. Since WPX requested to
- 22 present this case -- both of these cases by affidavit, WPX
- 23 submitted its exhibits to the Division on April 28 --
- 24 hearing.
- 25 Included with the exhibit packet are all of the

- 1 standard exhibits. First are the compulsory pooling
- 2 application checklist for both cases, as well as copies of
- 3 both of the applications.
- 4 Exhibit C is the affidavit of WPX's landman in
- 5 this case, Brennan West. And he has explained that in case
- 6 20374, WPX is seeking an order pooling all interest in the
- 7 Wolfcamp underlying a 636-acre horizontal spacing unit.
- 8 This is in the NE/4 of Section 35, the N/2 of
- 9 Section 36, both in Township 22 South, Range 28 East, and
- 10 Lots 1 and 2, as well as the E/2 of the NW/4 of Section 31,
- 11 and that is in Township 22 South, Range 29 East, in Eddy
- 12 County, New Mexico.
- The spacing unit is going to be dedicated to the
- 14 Golden re -- Golden Fed Com wells, and those are listed in
- 15 the affidavit, and C-102s are also provided.
- 16 In Case 20375 WPX seeks an order creating a
- 17 spacing unit in the Wolfcamp formation for a 633.85 acres
- 18 spacing unit comprised of the SE/4 of Section 35, the S/2 of
- 19 Section 36, both in Township 22 South and Range 28 East and
- 20 Lot 3 and 4, as well as the E/2 of the SW/4 of Section 31,
- 21 Township -- Range 29 East, and it's going to be dedicated to
- 22 the Retriever Fed Com wells.
- 23 And the C-102s are provided for those wells as
- 24 well with the land exhibits. WPX has reached agreement with
- 25 all working interest owners in the spacing unit, so in these

1 two pooling cases, WPX is only seeking to pool the override

- 2 royalty interest owners and those are provided on the
- 3 exhibit attached to the landman's affidavit.
- 4 WPX also provides Exhibit D, the standard geology
- 5 affidavit in Exhibit 4 of the Wolfcamp formation. And the
- 6 geologist provides the opinion -- location of the wells for
- 7 development of the Wolfcamp formation in this area.
- 8 Finally, WPX exhibits are the notice affidavit
- 9 and notice letter as well as the publication requesting that
- 10 notice of this hearing was provided in advance of this
- 11 hearing to parties to be pooled as required by the Division
- 12 rules.
- 13 So with that, I would move the admission of this
- 14 exhibit packet which comprises WPX Exhibits A through F.
- 15 HEARING EXAMINER ORTH: Are there objections from
- 16 counsel to the admission of the exhibits?
- 17 MS. BRADFUTE: Madam Examiner, there are no
- 18 objections from Marathon.
- 19 HEARING EXAMINER ORTH: Mr. Bruce?
- MR. BRUCE: No objection.
- 21 HEARING EXAMINER ORTH: All right, thank you.
- 22 The exhibits are admitted. Ms. Bradfute, do you have
- 23 questions of the -- before I turn it over to the other
- 24 hearing examiners?
- MS. BRADFUTE: No questions, thank you.

1 HEARING EXAMINER ORTH: Mr. Bruce?

- 2 MR. BRUCE: No questions.
- 3 HEARING EXAMINER ORTH: All right. Mr. Coss, do
- 4 you have questions of Ms. Luck?
- 5 EXAMINER COSS: Thank you. My question is out of
- 6 curiosity. What changed between that all of a sudden
- 7 Marathon dropped its objection and there was a lack of
- 8 competition? What happened there?
- 9 MS. BRADFUTE: Mr. Coss, this is Jennifer
- 10 Bradfute on behalf of Marathon.
- 11 WPX, their applications were involved in a larger
- 12 contested hearing. The parties reached an agreement to
- 13 revise the boundaries of different spacing units which
- 14 resolved some of the competing proposals at least between
- 15 WPX and Marathon.
- 16 EXAMINER COSS: Thank you.
- 17 HEARING EXAMINER ORTH: Anything else, Mr. Coss?
- 18 EXAMINER COSS: Were those -- were those
- 19 compulsory pooling cases that were brought to hearing? If
- 20 so, are the members listed in the packet?
- 21 MS. BRADFUTE: Mr. Coss, no, they were not
- 22 matters that have been brought to hearing yet. They are
- 23 still pending. They were set for a special docket, and that
- 24 docket was canceled due to the COVID-19 epidemic, so those
- 25 cases are going to be still going to hearing.

Page 8 EXAMINER COSS: I see. Okay. Well, I will be 1 2 curious to see that when they come up at a subsequent hearing. 3 4 MS.
