**STATEMENT OF THE CASE**

In **Case No. 22669**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2N/2 of Sections 35 and 36, Township 19 South, Range 28 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Uluru 35 Fed State Com 201H well which will be horizontally drilled from a surface hole location in the NW/4NW/4 (Unit D) of Section 35 to a bottom hole location in the SE/4NE/4 (Unit H) of Section 36.

In **Case No. 22670**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2S/2 of Sections 35 and 36, Township 19 South, Range 28 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Uluru 35 Fed State Com 202H well which will be horizontally drilled from a surface hole location in the SW/4SW/4 (Unit M) of Section 35 to a bottom hole location in the NE/4SE/4 (Unit I) of Section 36.

In **Case No. 22671**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2S/2 of Sections 35 and 36, Township 19 South, Range 28 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the Uluru 35 Fed State Com 203H well which will be horizontally drilled from a surface hole location in the SE/4SE/4 (Unit P) of Section 35 to a bottom hole location in the SE/4SE/4 (Unit P) of Section 36.

Also to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells. The Wells are located approximately 12 miles northeast of Carlsbad, New Mexico.
