APPLICANT'S STATEMENT OF CASE

In **Case No. 22679**, Ameredev seeks an order pooling all uncommitted interest in the Bone Spring formation [WC-025 G-08 S263620C; LWR Bone Spring (98150)] underlying a 320-acre, more or less, standard horizontal well spacing unit comprised of the E/2 E/2 of Sections 29 and 32, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico. Ameredev proposes to dedicate the above-referenced spacing unit to the **Red Bud 25-36-32 State Com 098H** (API 30-025-49591) to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 32 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 29.

In **Case No. 22680**, Ameredev seeks an order pooling all uncommitted interest in the Wolfcamp formation [Jal; Wolfcamp, West (33813)] underlying a 640-acre, more or less, standard horizontal well spacing unit comprised of the E/2 E/2 of Sections 29 and 32 and the W/2 W/2 of Sections 28 and 33, Township 25 South, Range 36 East, NMPM, Lea County, New Mexico. Ameredev proposes to dedicate the above-referenced spacing unit to the proposed **Red**

Bud 25-36-32 State Com 107H (API 30-025-49593) and the **Red Bud 25-36-32 State Com 118H** (API pending) to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 32 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 29. The completed interval of the Red Bud 25-36-32 State Com 118H will be within 330 feet of the offsetting quarter-quarter sections or equivalent tracts to allow inclusion of these tracts in a standard horizontal spacing unit for oil wells.
