#### APPLICATION OF ENDURING RESOURCES, LLC TO AMEND ORDER NO. R-14347 TO EXPAND THE SOUTH ESCAVADA UNIT AREA, SANDOVAL COUNTY, NEW MEXICO.

#### CASE NO. 22952

#### ENDURING RESOURCES, LLC'S MOTION TO SET A CONTESTED HEARING AND ISSUE A PREHEARING ORDER

Enduring Resources, LLC ("Enduring") requests that the New Mexico Oil Conservation Division ("Division") set this case for a contested hearing for the October 6, 2022, hearing date and issue a standard prehearing order accordingly. In support of this motion, Enduring states the following:

#### BACKGROUND

1. On July 5, 2022, in the above-captioned case, Enduring filed an application to amend Division Order No. R-14347 to expand the South Escavada Unit area to include an additional 160-acre tract of Allotted Indian lands, under the terms of the Unit Agreement, that were recently leased to Enduring, comprised of the NE/4 of Section 22, Township 22 North, Range 7 West, NMPM, Sandoval County, New Mexico.

2. On August 30, 2022, counsel for Vivian Mitchell, Margery Chiquito and her family, and Mae Toledo, Betty Castillo, Eunice Charley, Charlotte Gordo, Dickson Castillo, Matilda A. George, and Raquel Harrison (collectively, "Allottees") filed an entry of appearance and motion for continuance to the October 6, 2022, hearing date.

3. On August 30, 2022, the Division approved the continuance filed by Allottees.

#### ARGUMENT

1. Seven minutes prior to the deadline, Allottees' counsel emailed Enduring's counsel providing notification of their intent to file an entry of appearance and a motion for continuance and requested Enduring's position. *See* Exhibit A.

2. One minute prior to the deadline, Allottees' counsel filed the motion and the Division granted the continuance, which moved the hearing date from September 1, 2022, to October 6, 2022.

3. Allottees are all owners in the existing unit, <u>not</u> the acreage that is proposed to be added.

4. Allottees' counsel has yet to communicate any concerns or issues with the application despite repeated requests by Enduring's counsel to identify what their concerns or issues might be. *See* **Exhibit A**. Counsel for Enduring has notified counsel for Allottees about this request for a contested hearing but have heard no response. *See id*.

5. Further delay is unnecessary and will be prejudicial to Enduring, which has plans to drill and complete three wells across the expanded acreage. In the interim, counsel will continue to try to identify and resolve concerns the Allottees may have. In the event concerns remain, Allottees can raise their issues with the Division at the hearing.

#### CONCLUSION

For the foregoing reasons, Enduring requests that the Division set this case for a contested hearing on October 6, 2022 and issue a standard prehearing order accordingly.
