APPLICATION

Mewbourne Oil Company applies for an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying a horizontal spacing unit comprised of the N/2 of Section 33, Township 22 South, Range 27 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

- 1. Applicant is an interest owner in the N/2 of Section 33, and has the right to drill a well or wells thereon.
- 2. Applicant proposes to drill the following wells to a depth sufficient to test the Wolfcamp formation:
 - (a) The Hot Shots 33 W0AD Fee Well No. 1H, with a first take point in the NE/4NE/4 of 33 and a last take point in the NW/4NW/4 of Section 33; and
 - (b) The Hot Shots 33 W0HE Fee Well No. 1H, with a first take point in the SE/4NE/4 of 33 and a last take point in the SW/4NW/4 of Section 33.

The N/2 of Section 33 will be dedicated to the wells.

- 3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the N/2 of Section 33 for the purposes set forth herein.
- 4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the wells or to otherwise commit their interests to the wells, certain interest owners have failed or refused to join in dedicating their interests.

Therefore, applicant seeks an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying the N/2 of Section 33, pursuant to NMSA 1978 §§70-2-17.

5. The pooling of all uncommitted mineral interest owners in the Wolfcamp formation underlying the N/2 of Section 33 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

WHEREFORE, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying the N/2 of Section 33;
- B. Designating applicant as operator of the wells;
- C. Considering the cost of drilling, completing, and equipping the wells, and allocating the cost among the wells' working interest owners;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Setting a 200% charge for the risk involved in drilling, completing, and equipping the wells in the event a working interest owner elects not to participate in the wells.

Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying a horizontal spacing unit comprised of the N/2 of Section 33, Township 22 South, Range 27 East, NMPM. SELF-AFFIRMED STATEMENT OF BRAD DUNN

Brad Dunn, being duly sworn upon his oath, deposes and states:

- 1. I am a landman for Mewbourne Oil Company ("Mewbourne"), and have personal knowledge of the matters stated herein. I have been qualified by the Division as an expert petroleum landman.
- 2. Pursuant to Division Rules, the following information is submitted in support of this compulsory pooling application
- 3. The purpose of this application is to force pool working interest owners into the Wolfcamp horizontal spacing unit described below, and in wells to be drilled in the unit.
- 4. The interest owners being pooled have been contacted regarding the proposed wells, but has failed or refused to voluntarily commit their interests to the wells.
- 5. A plat outlining the unit being pooled is submitted as Attachment A. Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Wolfcamp formation underlying a horizontal spacing unit comprised of the N/2 of Section 33, Township 22 South, Range 27 East, NMPM. The unit will be dedicated to the Hot Shots 33 W0AD Fee Well No. 1H, with a first take point in the NE/4NE/4 of 33 and a last take point in the NW/4NW/4 of Section 33, and the Hot Shots 33 W0HE Fee Well No. 1H, with a first take point in the SE/4NE/4 of 33 and a last take point in the SW/4NW/4 of Section 33. C-102s for the wells are also part of Attachment A.
- 6. The tracts in the unit, the leases, and the parties being pooled and their interests, are set forth in Attachment B.
- 7. In order to locate the interest owners, Mewbourne examined the county records, performed internet searches, checked telephone records, and searched Accurint and Whitepages.



- 8. Attachment C is a summary of communications and a sample copy of the proposal letters sent to the interest owners. Mewbourne has made a good faith effort to obtain the voluntary joinder of the working interest owners in the proposed wells, or to locate the interest owners.
- 9. Attachment D contains the Authorizations for Expenditure for the proposed wells. The estimated cost of the wells set forth therein is fair and reasonable, and comparable to the cost of other wells of similar depth and length drilled in this area of Eddy County.
- 10. Mewbourne requests overhead and administrative rates of \$8000/month for a drilling well and \$800/month for a producing well. These rates are fair, and comparable to the rates charged by other operators for wells of this type in this portion of Eddy County. They are also the rates set forth in the Joint Operating Agreement for the well unit. Mewbourne requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.
- 11. Mewbourne requests that the maximum cost plus 200% risk charge be assessed against a non-consenting working interest owner.
 - 12. Mewbourne requests that it be designated operator of the wells.
- 13. The attachments to this affidavit were prepared by me, or compiled from company business records.
- 14. Granting this application is in the interests of conservation and the prevention of waste.







- 2. I am a geologist for Mewbourne Oil Company ("Mewbourne"), and I am familiar with the geological matters involved in this case. I have been qualified by the Division as an expert petroleum geologist.
- 3. The following geological plats are attached hereto:
- (a) Attachment A is a structure map of the Wolfcamp formation, mapped on the top of the correlative Wolfcamp marker. It shows that structure dips to the east, and that the planned wellbores would drill perpendicular to strike. It also shows a line of cross-section, A-A'.
- (b) Attachment B is a south-north cross section. The well logs on the cross-section give a representative sample of the Wolfcamp formation in this area. The target zone for the wells is the Upper Wolfcamp Sand, and that zone is continuous across the well unit.
- 4. I conclude from the maps that:
- (a) The horizontal spacing unit is justified from a geologic standpoint.
- (b) Each quarter section in the unit will contribute more or less equally to production.
- (c) There is no faulting or other geologic impediment in the area which will affect the drilling of the subject wells.
- 5. Attachment C is a regional map that shows the Hot Shots drilling unit in relation to nearby cities, and its location in Eddy County, NM.
