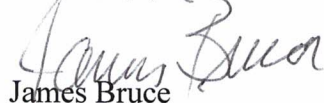
Ladies and gentlemen:

Enclosed is a copy of an application for compulsory pooling and a non-standard spacing and proration unit (Case No. 23390), filed with the New Mexico Oil Conservation Division by Mewbourne Oil Company, seeking an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a non-standard horizontal spacing unit comprised of the N/2 of Section 9 and the NE/4 of Section 8, Township 18 South, Range 29 East, N.M.P.M., Eddy County, New Mexico. The unit will be dedicated to: (a) the Double Stamp 9/8 B2AB Fed. Com. Well No. 1H, a horizontal well with a first take point in the NE/4NE/4 of Section 9 and a last take point in the NW/4NE/4 of Section 8; and (b) the Double Stamp 9/8 B2HG Fed. Com. Well No. 1H, a horizontal well with a first take point in the SE/4NE/4 of Section 9 and a last take point in the SW/4NE/4 of Section 8. The producing interval of each well will be orthodox. Applicant also requests approval to dedicate the wells to a non-standard 480-acre spacing and proration unit in the Sand Tank Bone Spring (oil) Pool.

This matter is scheduled for hearing at 8:15 a.m. on Thursday, March 2, 2023. During the current circumstances, state buildings are closed to the public and the hearing will be conducted remotely. This statement may be filed online with the Division at ocd.hearings@emnrd.nm.gov, and should include: The name of the party and his or her attorney; a concise statement of the case; the name(s) of the witness(es) the party will call to testify at the hearing; the approximate time the party will need

to present his or her case; and identification of any procedural matters that need to be resolved prior to the hearing. The Pre-Hearing Statement must also be provided to the undersigned.

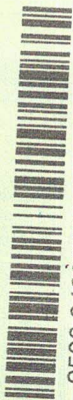

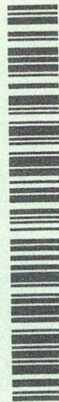

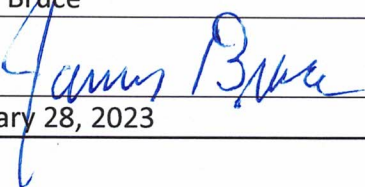
