Township 19 South, Range 28 East, Eddy County, New Mexico. The Order further dedicated the unit to the Uluru 35 Fed State Com 203H and designated Colgate as operator of the unit and well. Since the Order was entered, Colgate has identified additional interests in the unit that should be pooled under the terms of the Order.
