STATEMENT OF THE CASE

In **Case No. 23460**, TRO seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit (“Unit”) comprised of the N/2 of Sections 11 and 12, Township 25 South, Range 25 East, NMPM, Eddy County, New Mexico. The Unit will be dedicated to the following proposed initial wells (“Wells”): **High Life Federal Com #202H** and **High Life Federal Com #232H** to be horizontally drilled from a surface hole location in the SE/4NE/4 of Section 10 to a bottom hole location in the SE/4NE/4 of Section 12,

and **High Life Federal Com #211H** and **High Life Federal Com #231H** to be horizontally drilled from a surface hole location in the SE/4NE/4 of Section 10 to a bottom hole location in the NE/4NE/4 of Section 12. The completed interval for the **High Life Federal Com #202H** will be within 330' of the quarter-quarter line separating the N/2N/2 from the S/2N/2 of Sections 11 and 12 to allow the inclusion of this acreage into a standard horizontal spacing unit.

In **Case No. 23461**, TRO seeks an order pooling all uncommitted interests in the Wolfcamp formation underlying a 640-acre, more or less, standard horizontal spacing unit ("Unit") comprised of the S/2 of Sections 11 and 12, Township 25 South, Range 25 East, NMPM, Eddy County, New Mexico. The Unit will be dedicated to the following proposed initial wells ("Wells"): **High Life Federal Com #204H** and **High Life Federal Com #234H** to be horizontally drilled from a surface hole location in the NW/4SW/4 of Section 11 to a bottom hole location in the SE/4SE/4 of Section 12, and **High Life Federal Com #213H** and **High Life Federal Com #233H** to be horizontally drilled from a surface hole location in the NW/4SW/4 of Section 11 to a bottom hole location in the NE/4SE/4 of Section 12. The completed interval for the **High Life Federal Com #233H** will be within 330' of the quarter-quarter line separating the S/2S/2 from the N/2S/2 of Sections 11 and 12 to allow the inclusion of this acreage into a standard horizontal spacing unit.

Also, to be considered will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of TRO as operator of the Units and Wells, and a 200% charge for risk involved in drilling and completing the Wells. The Units are located approximately 3 miles southeast of Whites City, New Mexico.
