Order No. R-21100-B (the "Order") to allow for a one-year extension for drilling the proposed initial

well under the Order. In support, Applicant states:

1. Division Order No. R-21100, entered on February 12, 2020 in Case No. 20859,

created a 635.06-acre, more or less, standard horizontal spacing unit underlying the Lots 1-4 and

the S/2 N/2 (N/2 equivalent) of irregular Section 5, and Lots 1-5, the SE/4 NW/4, and the S/2 NE/4

(N/2 equivalent) of irregular Section 6, Township 22 South, Range 27 East, NMPM, Eddy County,

New Mexico (the "Unit"), and designated Applicant as the operator of the Unit.

2. Order No. R-21100 further pooled the uncommitted interests in the Wolfcamp

formation (Purple Sage; Wolfcamp Pool (Pool Code 98220)) in the Unit and dedicated the Unit to

the Betty #402H well (formerly Betty 5-6 WCXY 2H) (API No. 30-015-49015).

3. On April 12, 2021, the Division issued Order No. R-21100-A under Case No. 21576

pooling previously unidentified interest owners in the subject spacing unit and extending the drilling

deadline until February 12, 2022.

4. In July 2021, the Division issued an emergency order suspending approval of SPC's

initial well in a nearby spacing unit over concerns involving the Carlsbad Brine Well Remediation

Area. The Division subsequently determined that drilling and completing wells near the Brine Well

- 5. On January 4, 2022, SPC applied in Case No. 22534 to Amend Order No. R-21100-A to extend the drilling deadlines until February 12, 2023 due to the Division's suspension of drilling and completion activities.
- 6. After hearing, the Division issued Order No. R-21100-B on March 9, 2022, amending Order No. R-21100-A to extend the deadline to commence drilling until one year from the date SPC receives notice that the Division has determined remediation of the Carlsbad Brine Well is complete and that drilling and completion activities may resume. *See* Order No. R-21100-B at ¶ 20.
- 7. SPC received notice from the Division that remediation of the Carlsbad Brine Well was complete and that drilling and completion activities may resume on July 7, 2022. *See* Notice of Resumption, dated July 7, 2022, attached as **Exhibit A**. Accordingly, pursuant to Order No. R-21100-B, the deadline to commence drilling an initial well under the Order is July 7, 2023.
- 8. There is good cause for Applicant's request that the Order be amended to allow additional time to commence drilling the initial well under the Order.
- 9. Due to the disruption to SPC's initial drilling schedule, the suspension of its drilling and completion operations, and uncertainty over when the suspension would be lifted, SPC requires additional time to plan, coordinate, and retain a drilling crew to drill its planned initial well.
- 10. Accordingly, SPC requests the deadline to commence drilling an initial well under Order No. R-21100, as amended, be extended for one year until July 7, 2024.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on May 4, 2023, and, after notice and hearing as required by law, the Division amend Order No. R-21100, as amended, to extend the time to commence drilling the proposed initial well until July 7, 2024.

- 15. On January 4, 2022, SPC applied in Case No. 22535 to Amend Order No. R-21104-B to extend the drilling deadlines until February 17, 2023, due to the suspension of drilling and completion activities under the Division's July 2021 Emergency Order and Order No. R-21888 (for detail on the Emergency Order see paragraph 8 hereinabove).
- 16. After hearing on February 3, 2022, the Division issued Order No. R-21104-C on March 9, 2022, amending Order No. R-21104-B to extend the deadline to commence

drilling until one year from the date SPC receives notice that the Division has determined the remediation of the Carlsbad Brine Well is complete and that drilling and completion activities may resume. *See* Order No. R-21104-C at ¶ 20.

Accordingly, pursuant to Order Nos. R-21100-B and R-21104-C, SPC's deadline to commence drilling an initial well under each respective Order is July 7, 2023.
- 18. SPC requests that Order Nos. R-21100-B and R-21104-C be further amended to allow SPC additional time to commence drilling an initial well under each Order until July 7, 2024.
 - 19. Good cause exists for this requested extension of time in each case.
- 20. Due to the disruption to SPC's initial drilling schedule resulting from the Division's suspension of drilling and completion activities within the Carlsbad Brine Well Remediation Area and uncertainty over when the suspension would be lifted, SPC requires additional time to plan, coordinate, and retain a drilling crew to drill its planned initial wells.
- 21. SPC is in good standing with the Division's compliance requirements and regulations.
- 22. SPC has invested significant effort and time at substantial cost to identify and locate mineral owners within the subject acreage under these cases, reach voluntary agreement with many owners, and force pool interests that remain uncommitted.

- 23. SPC intends to drill the proposed wells, which are on SPC's drill schedule
- now that the Division's drilling moratorium has been lifted.
 - 24. No other operator has proposed to drill or develop the subject acreage.
- 25. None of the working interest owners that remain subject to the pooling orders have been asked to make an election on the applicable wells, or to pay their estimated share of the costs to drill, complete, and equip the applicable wells.
 - 26. In my opinion, an extension is justified under these circumstances.
- 27. Accordingly, SPC requests the deadline to commence drilling an initial well under Order Nos. R-21100-B and R-21104-C be extended for one year until July 7, 2024.
- 28. SPC provided notice to the parties subject to Order Nos. R-21100-B and R-21104-C. **SPC Exhibit B-2** is a copy of the notice letter and postal service tracking report reflecting the status of notices that were mailed by certified mail, return-receipt requested.
- 29. Granting these applications will further the interests of preventing waste and protecting correlative rights.
