STATEMENT OF THE CASE

Order No. R-13507-D ("Order") requires Targa to provide the Commission with (1) injection data covering the first four years of operation of the Red Hills AGI #1 Well (API No. 30-025-40448) ("Well"); and (2) an updated model of the projected scope of the injection plume after 30 years of injection, which shall be based on the injection data and any other relevant data concerning the reservoir. The Order further provides that after submitting the injection data and updated model, Targa may renew its request that the Commission eliminate the Order's requirement that it plug the Government L Com #001 Well (API 30-025-25604).

In accordance with the Order, Targa will present injection data for the first four years of operation of the Well and will provide the Commission with an updated model of the projected scope of the injection plume after 30 years of injection. Based on this data, as permitted by the Order, Targa renews its request that the Commission remove the Order's requirement that it plug the Government L Com #1H Well.
