SUPPLEMENTAL SELF-AFFIRMED STATEMENT OF ADAMS DAVENPORT

- 1. I am a landman at BTA Oil Producers, LLC ("BTA"). I previously submitted a self-affirmed statement in these matters.
- 2. At the May 4, 2023 hearing, the Division requested that BTA provide supplemental information regarding the requested overhead and administrative rates for the Capitan 22301 28-33 State Com #9H, Capitan 22301 28-33 State Com #10H, Capitan 22301 33-4 State Com #11H, and the Capitan 22301 33-4 State Com #12H wells ("Wells").
- 3. BTA requests overhead and administrative rates of \$12,000.00 per month while the Wells are being drilled and \$1,200.00 per month while the Wells are producing. As stated in my previously submitted self-affirmed statement, these rates are fair and are comparable to the rates charged by BTA and other operators in the vicinity.
- 4. As of November 2022, BTA's New Mexico horizontal wells under a JOA included average drilling and producing overhead rates of \$12,890.00 and \$1,289.00 per month, respectively. With the updated 2023 COPAS escalation rate of 8.5%, these averages would likely increase to \$13,985.65 and \$1,398.57.
- 5. Additionally, parties participating in the Wells have agreed to overhead and administrative rates of \$12,000.00 per month while the Wells are being drilled and \$1,200.00 per month while the Wells are producing.

6. BTA has also obtained and reviewed industry information regarding 2023 overhead rates that have been updated based on the escalated COPAS rates. The Wells will be drilled between the Delaware Basin and Midland Basin. For wells in that area, the average overhead rates

are \$12,625.00/\$1,262.50.

7. For these reasons, the requested overhead and administrative rates of \$12,000.00

per month while the Wells are being drilled and \$1,200.00 per month while the Wells are producing

are reasonable, fair and comparable to the rates charged in the vicinity.
