Thanks for reaching out on this. Upon reviewing the information, I can confirm that the coordinates of 32.027965, -103.277702 (NAD83) were selected as the revised surface location for the AGI well and the AOR analysis was centered around and completed for that location. Additionally, all maps, analyses, and supporting materials were completed and developed utilizing these surface location coordinates.

At the time of the amendment application development, the approximate footages for these coordinates (32.027965, -103.277702, NAD83) were estimated with ArcGIS mapping tools. Once the subsequent location survey required by Form C-102 was produced (using the NAD83 coordinates), it is apparent that the exact footage measurements slightly differ from the originally estimated footage calls.

Overall, the surveyed well location (C-102) is consistent with the surface location coordinates evaluated and described in the C-108 application, and we have no desire to further revise that

David, we are reviewing the APD for the Salt Creek replacement well. In my review of the APD (Action ID 240347), the C-108, and the latest order R-20913-F, I see two different surface locations provided:

- 1. Form C-102/APD: L-21-26S-36E Lot: 2329 FSL 278 FWL 32.027965,-103.277702 NAD83
- 2. R-20913-F contains the following Finding of Facts:
- 18. Salt Creek has submitted an Amended C-108 outlining the proposed revisions to the Well design, including the addition of two casing strings and a new drill location 277 feet from the West line and 2,350 feet from the South line of Section 21, Township 26 South, Range 36 East, resulting in an as-drilled location approximately 120 feet from the original

So what happened? Though the 21 feet seems "di minimus", you well know that this shifts the original AOR for notice and assessment for well penetrations approved by the OCC. This does need to be addressed. We will talk with the Director about procedure, hopefully to have the Director act as the Chair on behalf of OCC and approve if no notice is required and no new wells are identified. PRG
