STATEMENT OF THE CASE

Colgate seeks an order: (1) amending Order No. R-22118 to establish a 640-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 35 and 36, Township 19 South, Range 28 East, Lea County, New Mexico (“Unit”); and (2) pooling uncommitted interests in the Wolfcamp formation underlying the Unit. On August 29, 2022, the Division entered Order No. R-22218 (“Order”) in Case No. 22669. The Order: pooled all uncommitted interests in the Wolfcamp formation (East WC Burton Flat East, Upper Wolfcamp Pool (Code 98315)) underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Sections 35 and 36, Township 19 South, Range 28 East, Eddy County, New Mexico; dedicated the Unit to the

Uluru 35 Fed State Com 201H well (API No. 30-015-49654) (“Well”); and designated Colgate as operator of the Unit and Well.

Since entry of the Order, Colgate has determined that the Well will produce from the Winchester; Wolfcamp (Gas) Pool (Code 87760) rather than the East WC Burton Flat East, Upper Wolfcamp Pool (Code 98315). Because the Winchester; Wolfcamp (Gas) Pool (Code 87760) requires different spacing, Colgate seeks to amend Order No. R-22218 to form a 640-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Sections 35 and 36, Township 19 South, Range 28 East, Eddy County, New Mexico and pool uncommitted interests in the Wolfcamp formation underlying the Unit.

The Well is located approximately 12 miles northeast of Carlsbad, New Mexico.
