### **APPLICATION**

MRC Permian Company ("MRC" or "Applicant"), through undersigned attorneys, files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted mineral owners in a standard 240-acre, more or less, horizontal well spacing unit in the Bone Spring formation underlying the S2N2 of Section 33 and the S2NE4 of Section 32, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico. In support of its application, MRC states:

1. Applicant is a working interest owner in the proposed horizontal well spacing unit and has the right to drill thereon.

2. Applicant seeks to designate Matador Production Company (OGRID No. 228937) as the operator of the proposed horizontal spacing unit.

3. Applicant seeks to initially dedicate the above-referenced horizontal well spacing unit to the proposed **Alyson 3332 Fed Com 122H** well to be horizontally drilled from a surface hole location in the NE4NE4 (Unit A) of Section 33, with a first take point in the SE4NE4 (Unit H) and a last point in the SW4NE4 (Unit G) of Section 32.

4. Applicant has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject spacing unit.

5. The pooling of interests will allow Applicant to obtain a just and fair share of the oil and gas underlying the subject lands, avoid the drilling of unnecessary wells, will prevent waste, and will protect correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on September 7, 2023, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interest owners in the proposed horizontal well spacing unit;
- B. Designating Matador Production Company as operator of this horizontal well spacing unit and the wells to be drilled thereon;
- C. Authorizing Applicant to recover its costs of drilling, completing, and equipping the well;
- D. Approving the actual operating charges and costs of supervision while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- E. Imposing a 200% penalty for the risk assumed by Applicant in drilling and completing the well against any working interest owner who does not voluntarily participate in the drilling of the well.

### **AFFIDAVIT OF HAWKS HOLDER**

Hawks Holder, of lawful age and being first duly sworn, states the following:

1. My name is Hawks Holder and I am employed by MRC Energy Company, an affiliate of Matador Production Company ("Matador"), as a Landman.

2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My credentials as a petroleum landman have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by Matador in this case and the status of the lands in the subject area.

4. In this case, Matador seeks an order pooling all uncommitted mineral owners in a standard 240-acre, more or less, horizontal well spacing unit in the Bone Spring formation underlying the S/2 N/2 of Section 33 and the S/2 NE/4 of Section 32, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico. Matador proposes to dedicate the above-referenced spacing unit to the proposed initial **Alyson 3332 Fed Com 122H** well, to be horizontally drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 33, with a first take point in the SE/4 NE/4 (Unit H) of Section 33 and a last take point in the SW/4 NE/4 (Unit G) of Section 32.

5. **Matador Exhibit C-1** contains a draft Form C-102 for the initial well in the horizontal spacing unit. This form demonstrates that the completed internal for the well will meet the standard setback requirements for horizontal oil wells.

Matador understands that this Bone Spring well will be placed in the WC-015 G 04 S203032P; BONE SPRING [98008] pool.

7. **Matador Exhibit C-2** identifies the tracts of land comprising the proposed horizontal spacing unit. The subject acreage is comprised of state and federal acreage.

8. There are no depth severances within the Bone Spring formation underlying this acreage.

9. **Matador Exhibit C-3** identifies the overriding royalty interest owners that Matador is seeking to pool in the proposed horizontal spacing unit.

10. Matador is only seeking to pool overriding royalty interest owners. Because these are non-cost bearing interests, Matador has not included a sample well proposal, AFE, or a chronology of contacts, and is not requesting overhead and administrative penalty costs. Matador owns 100% of the working interest in the proposed spacing unit.

11. Matador has provided the law firm of Holland & Hart LLP with the names and addresses of the parties that Matador seeks to pool and instructed that they be notified of this hearing.

12. **Matador Exhibits C-1 through C-3** were either prepared by me or compiled under my direction and supervision.





# **SELF-AFFIRMED STATEMENT OF ANDREW PARKER**

1. My name is Andrew Parker. I work for MRC Energy Company, an affiliate of

Matador Production Company ("Matador"), as a Senior Vice President of Geoscience.

2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geology. My credentials as a petroleum geologist have been accepted by the Division and made a matter of record.

3. I am familiar with the applications filed by Matador in these cases, and I have conducted a geologic study of the lands in the subject area.

4. Matador Exhibit D-1 is a locator map outlining the horizontal spacing units with a black box shaded in yellow, with the larger area identified in a red box.

 In these cases, Matador intends to develop the Second Bone Spring of the Bone Spring formation.

6. Matador Exhibit D-2 is a subsea structure map prepared off the top of the Bone Spring formation. The contour interval is 50 feet. The structure map shows the Bone Spring

formation gently dipping to the southeast. The structure appears consistent across the proposed wellbore paths. I do not observe any faulting, pinchouts, or other geologic impediments to horizontal drilling.

7. Also included on Matador Exhibit D-2 is a line of cross section from A to A'.

8. Matador Exhibit D-3 is a structural cross-section prepared displaying open-hole logs run over the Bone Spring formation from the three representative wells denoted from A to A'. For each well in the cross-section, the following logs are included: gamma ray, caliper, porosity, and resistivity, where available. The proposed target intervals for each of the respective proposed

wells is labeled and marked with a yellow shaded area. The logs in the cross-section demonstrate

that the targeted intervals, within the Bone Spring formation, are consistent in thickness, across the entirety of the proposed spacing units.

9. In my opinion, the lay-down orientation is the preferred orientation for development in this area for Bone Spring wells because the maximum horizontal stress is north-south in this area.

10. Based on my geologic study of the area, I have not identified any geologic impediments to drilling horizontal wells within the Bone Spring formation in the area of the spacing units proposed in these cases.

11. In my opinion, each quarter-quarter section will be productive and contribute moreor-less equally to production from each horizontal spacing unit.

# 12. In my opinion, horizontal drilling will be the most efficient method to develop this

acreage, to prevent the drilling of unnecessary wells, and to result in the greatest ultimate recovery.

13. Approving Matador's applications will be in the best interest of conservation, the

prevention of waste, and protection of correlative rights.

14. Matador Exhibits D-1 through D-3 were either prepared by me or compiled under my direction and supervision.




### WC-015 G-04 S203032P; BONE SPRING, (98008) Structure Map (Top Bone Spring Subsea) A – A' Reference Line
