APPLICANT'S STATEMENT OF THE CASE

Under these consolidated cases, MRC seeks orders pooling all uncommitted interests in the Bone Spring (Culebra Bluff; Bone Spring, South [15011]) formation underlying the referenced acreage all in Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico, as follows:

- Under **Case No. 23670**, MRC seeks to pool a standard 240-acre, more or less, horizontal well spacing unit in the Bone Spring formation underlying the N/2 S/2 of Section 1 and N/2 SE/4 of Section 2 and initially dedicate this Bone Spring spacing unit to the proposed **Drew Dix Fed Com 113H, Drew Dix Fed Com 123H** and the **Drew Dix Fed Com 133H** wells to be horizontally drilled with first take points located in the NE/4 SE/4 (Unit I) of Section 1 and last take points located in the NW/4 SE/4 (Unit J) of Section 2.
- Under **Case No. 23671**, MRC seeks an order (a) approving a standard 240-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation underlying the S/2 S/2 of Section 1 and S/2 SE/4 of Section 2, and (b) pooling all uncommitted mineral interests in this horizontal well spacing unit. MRC seeks to initially dedicate the above-referenced overlapping horizontal well spacing unit to the proposed **Dew Dix Fed Com 114H, Dew Dix Fed Com 124H** and the **Dew Dix**

Fed Com 134H wells to be horizontally drilled with first take points located in the SE/4 SE/4 (Unit P) of Section 1 and last take points located in the SW/4 SE/4 (Unit O) of Section 2. This proposed horizontal well spacing unit will overlap a 160-acre horizontal well spacing unit comprised of the S/2 S/2 of Section 1 that is currently dedicated to the Dr. Scrivener Federal 01-24S-28E RB 124H well (API No. 30-15-43820) operated by Matador Production Company.

The completed interval for each of the wells will comply with statewide setbacks for oil wells. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
