APPLICANT’S STATEMENT OF THE CASE

In Case No. 23780, V-F Petroleum seeks (1) establishing a non-standard 320-acre, more or less, spacing and proration unit comprised of the S/2 of Section 33, Township 18 South, Range 28 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests from

a stratigraphic equivalent of 3,531 feet (that being the top of the Bone Spring formation) in the Travis; Bone Springs formation [Pool Code 97257], to a stratigraphic equivalent of 7,062 feet (that being the base of the 2nd Bone Springs Sand formation), depths as defined on the log for the Man State #001H (API No. 30-015-35282), designated as an oil pool, underlying said 320-acre unit. V-F Petroleum proposes and dedicates to the HSU the **Buchanan 33 State Com #221H Well** and the **Buchanan 33 State Com #222H Well** as initial wells to be drilled to a sufficient depth to test the Bone Spring formation.

V-F Petroleum proposes the **Buchanan 33 State Com #221H Well**, an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 33 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 33.

V-F Petroleum proposes the **Buchanan 33 State Com #222H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 SE/4 (Unit I) of Section 33 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 33.

All the wells proposed herein are orthodox in their location, and the take points and completed intervals comply with setback requirements under the statewide rules.

The proposed non-standard HSU would have been a standard unit comprising the S/2 of Section 33 if a proximity well had been utilized; however, optimal spacing does not support the use of proximity well. With the proposed well locations, V-F Petroleum will be able to reduce surface and facility costs thus preventing waste. V-F Petroleum will apply with the Division for administrative approval of the non-standard HSU.
