Mewbourne Oil Company applies for an order amending Order No. R-22706 to pool additional uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2NE/4 of Section 11 and the S/2N/2 of Section 12, Township 18 South, Range 31 East, N.M.P.M., Eddy County, New Mexico, and Lot 2 and the SE/4NW/4 (the S/2NW/4) of Section 7, Township 18 South, Range 32 East, N.M.P.M., Lea County, New Mexico, and in support thereof, states:

1. Applicant is an interest owner in the S/2NE/4 of Section 11, the S/2N/2 of Section 12, and the S/2NW/4 of Section 7 (containing 320 acres), and has the right to drill a well thereon.
2. Applicant proposes to drill the Iron Islands 11/7 B2GF Fed. Com. Well No. 1H to a depth sufficient to test the Bone Spring formation, with a first take point in the SW/4NE/4 of Section 11 and a last take point in the SE/4NW/4 of Section 7.
3. Applicant has in good faith sought to obtain the voluntary joinder of all other mineral interest owners in the S/2NE/4 of Section 11, the S/2N/2 of Section 12, and the S/2NW/4 of Section 7 for the purposes set forth herein.
4. Although applicant attempted to obtain voluntary agreements from all mineral interest owners to participate in the drilling of the well or to otherwise commit their interests to the well, certain interest owners have failed or refused to join in dedicating their interests. Therefore, applicant seeks an order pooling all uncommitted mineral interest owners in the Bone


Spring formation underlying the S/2NE/4 of Section 11, the S/2N/2 of Section 12, and the S/2NW/4 of Section 7, pursuant to NMSA 1978 §70-2-17.

5. The pooling of all mineral interest owners in the Bone Spring formation underlying the S/2NE/4 of Section 11, the S/2N/2 of Section 12, and the S/2NW/4 of Section 7 will prevent the drilling of unnecessary wells, prevent waste, and protect correlative rights.

**WHEREFORE**, applicant requests that, after notice and hearing, the Division enter its order:

- A. Pooling all uncommitted mineral interest owners in the Bone Spring formation (Tamano; Bone Spring/Pool Code 58040) underlying the S/2NE/4 of Section 11, the S/2N/2 of Section 12, and the S/2NW/4 of Section 7;
- B. Designating applicant as operator of the well;
- C. Considering the cost of drilling, completing, and equipping the well, and allocating the cost among the well's working interest owners;
- D. Approving actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure; and
- E. Setting a 200% charge for the risk involved in drilling, completing, and equipping the well in the event a working interest owner elects not to participate in the well.

***Application of Mewbourne Oil Company to amend Order No. R-22706 for compulsory pooling, Eddy County and Lea County, New Mexico.*** Mewbourne Oil Company seeks an order amending Order No. R-22706 to pool additional uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2NE/4 of Section 11 and the S/2N/2 of Section 12, Township 18 South, Range 31 East, NMPM (Eddy County), and Lot 2 and the SE/4NW/4 (the S/2NW/4) of Section 7, Township 18 South, Range 32 East, NMPM (Lea County). The unit will be dedicated to the Iron Islands 11/7 B2GF Fed. Com. Well No. 1H, with a first take point in the SW/4NE/4 of Section 11 and a last take point in the SE/4NW/4 of Section 7. Also to be considered will be the cost of drilling, completing, and equipping the well and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the well, and a 200% charge for the risk involved in drilling, completing, and equipping the well. The unit is located approximately 10 miles southeast of Loco Hills, New Mexico.

**SELF-AFFIRMED STATEMENT OF BRAXTON BLANDFORD**

Braxton Blandford deposes and states:

1. I am a landman for Mewbourne Oil Company ("Mewbourne"), and have personal knowledge of the matters stated herein. I have previously testified before the Division and my qualifications as an expert in petroleum land matters was accepted of record.
2. Pursuant to Division Rules, the following information is submitted in support of the compulsory pooling application filed herein.
3. The purpose of these applications is to force pool uncommitted working interest owners into the Bone Spring horizontal spacing units described below, and in wells to be drilled in the units.
4. No opposition is expected because the interest owners being pooled have been contacted regarding the proposed wells, but have failed or refused to voluntarily commit their interests to the well.
5. In this application Mewbourne seeks an order amending Order No. R-22706 to pool additional uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2NE/4 of Section 11 and the S/2N/2 of Section 12, Township 18 South, Range 31 East, NMPM (Eddy County), and Lot 2 and the SE/4NW/4 (the S/2NW/4) of Section 7, Township 18 South, Range 32 East, NMPM (Lea County) The unit will be dedicated to the Iron Islands 11/7 B2GF Fed. Com. Well No. 1H. Plats outlining the well unit being pooled are submitted as Exhibits 2-A and 2-B.
6. There is no depth severance in the Bone Spring formation.
7. The working interest owners being pooled are Stewart Heighten, Trustee of the Boyd Brigham Heighten Trust, and Riverhill Energy Corporation. These interest owners were found due to additional title examination. Exhibit 2-C is a summary of communications and a copy of the proposal letter sent to the uncommitted working interest owners.

Mewbourne also seeks to pool a number of Record Title owners in the federal leases in the well unit. That is necessary to obtain approval of a communitization agreement for the well unit.

8. Mewbourne has made a good faith effort to locate and obtain the voluntary joinder of the uncommitted working interest owners and record title owners in the proposed well.

10. An Authorization for Expenditure for the proposed well is submitted as Exhibit 2-D. The estimated cost of the well set forth therein is fair and reasonable, and comparable to the costs of other wells of similar depth and length drilled in this area of Eddy and Lea Counties.

11. Mewbourne requests overhead and administrative rates of \$8000/month for a drilling well and \$800/month for a producing well. These rates are fair, and comparable to the rates charged by other operators for wells of this type in this portion of Eddy and Lea Counties. They are also the rates set forth in the Joint Operating Agreement for the well unit. Mewbourne requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

12. Mewbourne requests that the maximum cost plus 200% risk charge be assessed against non-consenting working interest owners.

13. Mewbourne requests that it be designated operator of the well.

14. The attachments to this affidavit were prepared by me, or compiled from company business records.

15. The granting of this application is in the interests of conservation and the prevention of waste.
