**STATEMENT OF THE CASE**

In **Case No. 23951**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 8 and 17, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Butters Stotch 8 State Com 122H** well, which will be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 17 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 8.

In **Case No. 23952**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 17 and the W/2 SE/4 of Section 8, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Butters Stotch 8 State Com 123H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 8 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 17.

In **Case No. 23954**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 240-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Section 17 and the E/2 SE/4 of Section 8, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Butters Stotch 8 State Com 124H** well, which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 8 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 17.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The wells are located approximately 13 miles west of Eunice, New Mexico.
