**STATEMENT OF THE CASE**

In **Case No. 23955**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 322.26-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 5 and 8, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Casa Bonita 32 State Com 121H** well, which will be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 32, Township 21 South, Range 35 East to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 8, Township 22 South, Range 35 East.

In **Case No. 23956**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 242.11-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 5 and the W/2 NE/4 of Section 8, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to **Casa Bonita 8 State Com 123H** well, which will be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 8 to a bottom hole location in the NW/4 NE/4 (Lot 2) of Section 5.

In **Case No. 23957**, Permian Resources applies for an order pooling all uncommitted interests in the Bone Spring formation underlying a 242.04-acre, more or less, standard horizontal spacing unit comprised of the E/2 E/2 of Section 5 and the E/2 NE/4 of Section 8, Township 22 South, Range 35 East, Lea County, New Mexico. The Unit will be dedicated to the **Casa Bonita 8 State Com 124H** well, which will be drilled from a surface hole location in the SE/4 NE/4 (Unit H) of Section 8 to a bottom hole location in the NE/4 NE/4 (Lot 1) of Section 5.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells. The wells are located approximately 13 miles west of Eunice, New Mexico.
