# **APPLICANT'S STATEMENT OF CASE**

In Case No. 24083, Devon seeks to reopen Case No. 23316 and amend Order No. R-22671 in order to pool certain additional owner or owners recently discovered, in the Yeso formation (Atoka: Glorieta-Yeso [Pool Code 3250]), an oil pool, underlying the standard 160-acre, more or

less, spacing and proration unit comprised of the S/2 S/2 of Section 22, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico. Silverback proposed and dedicated to the unit the **Krauss 22 D #101H Well, Krauss 22 D #201H Well,** and **Krauss 22 D #202H Well,** as initial wells. The proposed wells will be orthodox in location.

Silverback proposed the **Krauss 22 D #101H Well,** an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 22 to a bottom hole location in the SW/4 SW/4 (Unit M) of same Section 22.

Silverback proposed the **Krauss 22 D #201H Well,** an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 22 to a bottom hole location in the SW/4 SW/4 (Unit M) of same Section 22.

Silverback proposed the **Krauss 22 D #202H Well,** an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 22 to a bottom hole location in the SW/4 SW/4 (Unit M) of same Section 22.
