APPLICATION OF SPC RESOURCES, LLC TO AMEND ORDER NO. R-21096, AS AMENDED, EDDY COUNTY, NEW

<u>APPLICATION</u>

SPC Resources, LLC ("Applicant") (OGRID No. 372262), through its undersigned

attorneys, hereby files this application with the Oil Conservation Division to amend Order No. R-

21096, as amended, to allow for a one-year extension of time to drill an initial a well under

the Order until February 17, 2025. In support of this application, Applicant states:

1. Division Order No. R-21096, entered on February 12, 2020 in Case No. 20762,

created a 1,267.1-acre, more or less, standard horizontal spacing unit consisting of the W/2 and

E/2 of Section 12, Township 22 South, Range 26 East, and the W/2 and E/2 of Section 7,

Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the "Unit"), and

designated Applicant as the operator of the Unit.

2. Order No. R-21096 pooled the uncommitted interests in the Wolfcamp formation

(Purple Sage; Wolfcamp Pool (Pool Code 98220)) in the Unit and dedicated the Unit to the

following Proposed Wells: (1) the Caveman #402H well (API No. 30-015-53285), and (2) the

Caveman #442H well (API 30-015-53280).

3. On April 12, 2021, the Division entered Order No. R-21096-A in Case No. 21577

to (1) conform Order No. R-21096 to the amended order template ("Amended Order") described

in the Division Director's April 9, 2020 Letter to Counsel Regarding Amended CP Order

Template; (2) pool additional interest owners under the terms of Order No. R-21096; (3) extend

the time to commence drilling an initial well under Order No. R-21096 to February 12, 2022; and (4) update the names and locations of the initial Proposed Wells.

- 4. On May 17, 2021, the Division entered Order No. R-21096-B, pooling additional interest owners under the terms of Order No. R-21096 without modifying the February 12, 2022, drilling deadline.
- 5. Applicant was under contract with a drilling crew and preparing to spud an initial well under Order No. R-21096 in July 2021 when the Division issued an emergency order suspending approval of SPC's initial well.
- 6. Subsequently, the Division filed an application to revoke Order No. R-21096, as amended, and the approved APDs for the initial wells.
- 7. On October 19, 2021, the Division entered Order No. R-21888 temporarily suspending Order No. R-21096 pending remediation of the Carlsbad Brine Well project and until other certain conditions were met. All deadlines under Order No. R-21096 were tolled effective July 2, 2021 until the Division Director notified SPC that drilling and/or completion activities may resume.
- 8. The Division notified SPC on July 7, 2022, that suspension of Order No. R-21096 had been lifted and that drilling and completion activities may resume, but only outside a one-mile radius around the Carlsbad Brine Well. Pursuant to the tolling of Order No. R-20196, the deadline to commence drilling an initial well was February 17, 2023.
- 9. While the Division authorized resumption of drilling and completion activities outside a one-mile radius of the Carlsbad Brine Well, the suspension remained effective within a one-mile radius. The spacing unit authorized under Order No. R-21096 is partially within the one-mile radius subject to the continued suspension.

- 10. In the interim, Applicant drilled and completed other wells outside the one-mail radius adjacent to the spacing unit approved under Order No. R-21096, namely the Barney #404H (API No. 30-015-49097) and Barney #434H (API No. 30-015-49107) approved under Order No. R-21123, as amended, pending the Division's decision to lift suspension of activities within the one-mile radius.
- 11. Due to the disruption to SPC's initial drilling schedule, suspension of its drilling and completion operations, the remaining suspension of activity within a one-mile radius of the Carlsbad Brine Well, and uncertainty over when the complete suspension would be lifted, SPC required additional time to plan, coordinate, and retain a drilling crew to drill its planned initial wells.
- 12. On November 16, 2022, Applicant filed an application under Case No. 23218 to further amend Order No. R-21096, as amended, to allow additional time to commence drilling an initial well until February 17, 2024.
- 13. Applicant presented Case No. 23218 at hearing on January 4, 2023, but the Division did not issue an order until August 4, 2023, when it approved the request to extend the deadline to commence drilling until February 17, 2024, under Order No. R-21096-C.
- 14. However, the Division did not lift the suspension of drilling and completion activities within a one-mile radius until November 13, 2023, when it issued the Amended Notice and Resumption of Drilling and Completion Activity in Proximity to the Carlsbad Brine Well.
- 15. Applicant now seeks an additional one-year extension to commence drilling until February 17, 2025.
 - 16. Good cause exists for Applicant's request for an extension of time.

17. Accordingly, SPC requests the deadline to commence drilling an initial well under Order No. R-21096, as amended, be extended for one year until February 17, 2025.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on January 4, 2024, and after notice and hearing as required by law, the Division amend Order No. R-21096, as amended, to extend the time to commence drilling the proposed initial well until February 17, 2025.

SELF-AFFIRMED STATEMENT OF CHRIS ASTWOOD

1. My name is Chris Astwood. I work for Permian Resources Operating, LLC ("Permian") as a Senior Landman. SPC Resources, LLC ("SPC Resources") is a wholly owned subsidiary of Permian. Permian closed on the acquisition of SPC Resources in December 2023 with an effective date in September 2023.

2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness. My credentials in petroleum land matters have been accepted by the Division and made a matter of record.

3. I am familiar with the application filed by SPC Resources in this case, and I am familiar with the status of the lands in the subject area.

4. None of the parties in this case have indicated opposition, therefore I do not expect any opposition at the hearing.

5. In this case, SPC seeks an order to amend Order No. R-21096, as amended, to allow for a final extension of time to drill an initial a well under the Order until February 17, 2025.

6. Division Order No. R-21096, entered on February 12, 2020 in Case No. 20762, created a 1,267.1-acre, more or less, standard horizontal spacing unit consisting of the W/2 and E/2 of Section 12, Township 22 South, Range 26 East, and the W/2 and

Case No. 24062

E/2 of Section 7, Township 22 South, Range 27 East, NMPM, Eddy County, New Mexico (the "Unit"), and designated Applicant as the operator of the Unit.

- 7. Order No. R-21096 pooled the uncommitted interests in the Wolfcamp formation (Purple Sage; Wolfcamp Pool (Pool Code 98220)) in the Unit and dedicated the Unit to the following Proposed Wells: (1) the Caveman #402H well (API No. 30-015-53285), and (2) the Caveman #442H well (API 30-015-53280).
- 8. On April 12, 2021, the Division entered Order No. R-21096-A in Case No. 21577 to (1) conform Order No. R-21096 to the amended order template ("Amended Order") described in the Division Director's April 9, 2020 *Letter to Counsel Regarding Amended CP Order Template*; (2) pool additional interest owners under the terms of Order No. R-21096; (3) extend the time to commence drilling an initial well under Order No. R-21096 to February 12, 2022; and (4) update the names and locations of the initial Proposed Wells.
- 9. On May 17, 2021, the Division entered Order No. R-21096-B, pooling additional interest owners under the terms of Order No. R-21096 without modifying the February 12, 2022, drilling deadline.
- 10. Applicant was under contract with a drilling crew and preparing to spud an initial well under Order No. R-21096 in July 2021 when the Division issued an emergency order suspending approval of SPC's initial well.
- 11. Subsequently, the Division filed an application to revoke Order No. R-21096, as amended, and the approved APDs for the initial wells.
- 12. On October 19, 2021, the Division entered Order No. R-21888 temporarily suspending Order No. R-21096 pending remediation of the Carlsbad Brine Well project and until other certain conditions were met. All deadlines under Order No. R-21096 were

tolled effective July 2, 2021, until the Division Director notified SPC that drilling and/or completion activities may resume.

- 13. The Division notified SPC on July 7, 2022, that suspension of Order No. R-21096 had been lifted and that drilling and completion activities may resume, but only outside a one-mile radius around the Carlsbad Brine Well. Pursuant to the tolling of Order No. R-20196, the deadline to commence drilling an initial well was February 17, 2023.
- 14. While the Division authorized resumption of drilling and completion activities outside a one-mile radius of the Carlsbad Brine Well, the suspension remained effective within a one-mile radius. The spacing unit authorized under Order No. R-21096 is partially within the one-mile radius that was subject to the continued suspension.
- 15. In the interim, Applicant drilled and completed other wells outside the one-mail radius adjacent to the spacing unit approved under Order No. R-21096, namely the Barney #404H (API No. 30-015-49097) and Barney #434H (API No. 30-015-49107) approved under Order No. R-21123, as amended, pending the Division's decision to lift suspension of activities within the one-mile radius.
- 16. Due to the disruption to SPC's initial drilling schedule, suspension of its drilling and completion operations, the remaining suspension of activity within a one-mile radius of the Carlsbad Brine Well, and uncertainty over when the complete suspension would be lifted, SPC required additional time to plan, coordinate, and retain a drilling crew to drill its planned initial wells under Order No. R-21096, as amended.
- 17. On November 16, 2022, Applicant filed an application under Case No. 23218 to allow additional time under Order No. R-21096 to commence drilling an initial well until February 17, 2024.

- 18. Applicant presented Case No. 23218 at hearing on January 4, 2023, but the Division did not issue an order until August 4, 2023, when it approved the request to extend the deadline to commence drilling until February 17, 2024, under Order No. R-21096-C. The delay in issuing an order left uncertain Applicant's authority to drill and complete a well.
- 19. In addition, the Division did not lift the suspension of drilling and completion activities within the one-mile radius of the Carlsbad Brine Well until November 13, 2023, when it issued the Amended Notice and Resumption of Drilling and Completion Activity in Proximity to the Carlsbad Brine Well.
- 20. Applicant now seeks a final one-year extension to commence drilling until February 17, 2025.
 - 21. Good cause exists for Applicant's request for an extension of time.
- 22. Due to the disruption to SPC's initial drilling schedule resulting from the Division's suspension of drilling and completion activities within the Carlsbad Brine Well Remediation Area and uncertainty over when the suspension would be lifted, SPC requires additional time to plan, coordinate, and retain a drilling crew to drill its planned initial wells.
- 23. SPC is in good standing with the Division's compliance requirements and regulations.
- 24. SPC has invested significant effort and time at substantial cost to identify and locate mineral owners within the subject acreage in this case, reach voluntary agreement with many owners, and force pool interests that remain uncommitted.

- 25. As part of its acquisition of SPC, Permian has hit the ground running but still requires an extension to meet the drilling deadline under the Order. SPC intends to drill the proposed wells, which are on SPC's drill schedule for June 2024, now that the Division's drilling moratorium has been lifted.
 - 26. No other operator has proposed to drill or develop the subject acreage.
- 27. At this time, none of the working interest owners that remain subject to the pooling order have been asked to make an election on the initial wells, or to pay their estimated share of the costs to drill, complete, and equip the initial wells.
- 28. No pooled mineral interest has objected to the requested extension and there are no competing plans to develop this acreage.
- 29. Several SPC leases within this acreage are coming up for expiration in 2024. While SPC can extend these leases by exercising contractual lease-extension provisions, if the Order is not extended SPC will be required to go through the compulsory pooling process again to re-pool hundreds of mineral owners. That will substantially delay SPC's drilling plan and impose an unnecessary administrative burden on the Division.
- 30. Approving this final extension is therefore the most expedient way to ensure the initial wells are timely drilled and SPC's leases and its correlative rights are protected. The alternative would require SPC to go through the process of re-proposing its wells, re-notifying all parties who were just notified of the requested extension (and did not object), re-present its pooling case, and await an order pooling all uncommitted interests. In contrast, a final extension of the pooling order would allow SPC to focus on the sole task of preparing to drill and meeting its existing lease deadlines.

- 31. In my opinion, an extension is justified under the totality of the foregoing circumstances.
- 32. Accordingly, SPC requests the deadline to commence drilling an initial well under Order No. R-21096, as amended, be extended for one year until February 17, 2025.
- 33. SPC provided notice to the parties subject to Order No. R-21096, as amended. **SPC Exhibit B-1** is a copy of the notice letter and postal service tracking report reflecting the status of notices that were mailed by certified mail, return-receipt requested.
- 34. Granting these applications will further the interests of preventing waste and protecting correlative rights.
- 35. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in this case. This statement is made on the date next to my signature below.
