### **APPLICANT'S STATEMENT OF THE CASE**

In Case No. 24253, Cimarex seeks an order pooling all uncommitted mineral interests in the Bone Spring formation underlying a standard 479.39-acre, more or less, horizontal spacing unit comprised of the S/2 N/2 of Sections 2 and 1, Township 20 South, Range 29 East; and the S/2 N/2 of Section 6, Township 20 South, Range 30 East; NMPM, Eddy County, New Mexico. Sections 2, 1, and 6 are irregular sections with correction lots.

Cimarex proposes and dedicates to the HSU the **Crest 2-1-6 State Fed Com 2H Well** as the initial well to be drilled to a sufficient depth to test the Bone Spring formation.

Cimarex proposes the **Crest 2-1-6 State Fed Com 2H Well**, an oil well, to be horizontally drilled from a surface location in the SW/4 NW/4 (Unit E) of Section 2 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 6.

The well is orthodox, and the completed interval and first and last take points for the well meet the setback requirements set forth in the Division's statewide rules and regulations for horizontal oil wells.

There exists one overlapping unit involving the Superior Federal 10H (API 30-015-38465), operated by Cimarex, covering the W/2 W/2 of Section 1. Cimarex seeks approval for this overlapping unit pursuant to Rule 19.15.16.15(B)(9)(b).
