**STATEMENT OF THE CASES**

In these cases, Colgate seeks to pool additional interests under the terms of Order Nos. R-23008 and R-23009.

On January 10, 2024, the Division entered Order No. R-23008 in Case No. 23666, which pooled uncommitted interests in the Bone Spring formation underlying a standard horizontal

spacing unit comprised of the N/2 NW/4 of Section 29 and the N/2 N/2 of Section 30, Township 18 South, Range 31 East, Eddy County, New Mexico. Order No. R-23008 further dedicated the unit to the Long John 29-30 Fed Com 121H and Long John 29-30 Fed Com 131H wells and designated Permian Resources Operating, LLC (OGRID No. 372165) as operator of the unit and wells.

The Division entered Order No. R-23009 in Case No. 23667 on January 10, 2024. Order No. R-23009 pooled uncommitted interests in the Bone Spring formation underlying a standard horizontal spacing unit comprised of the S/2 NW/4 of Section 29 and the S/2 N/2 of Section 30, Township 18 South, Range 31 East, Eddy County, New Mexico. Order No. R-23009 further dedicated the unit to the Long John 29-30 Fed Com 122H and Long John 29-30 Fed Com 132H wells and designated Permian Resources Operating, LLC (OGRID No. 372165) as operator of the unit and wells.

Since Order Nos. R-23008 and R-23009 were entered, Colgate has identified additional uncommitted interests in the Unit that have not been pooled under the terms of the Order. Colgate requests that these additional interest owners be pooled under the terms of Order Nos. R-23008 and R-23009.
