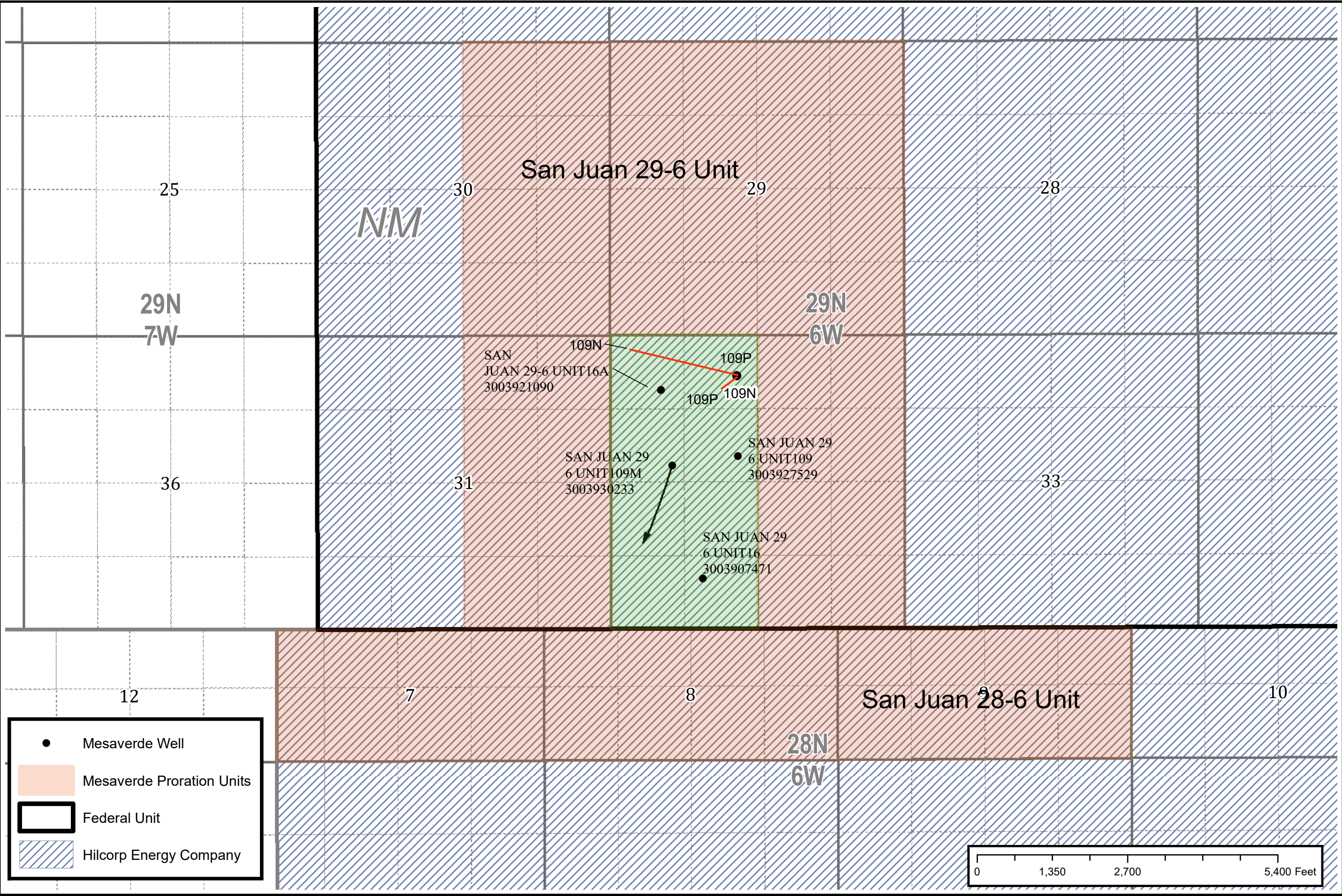

Applicant in the above-styled cause seeks an order

for an exception to the well density requirements of Rule I.B of the Special Rules and Regulations for the Blanco-Mesaverde Gas Pool (72319), Rio Arriba County, New Mexico, to permit it to drill and complete two additional Mesaverde vertical and/or directional gas wells, making a total of six vertical and/or directional gas wells within the same standard 320-acre, more or less, spacing and proration unit. Hilcorp further seeks approval for the proposed locations of the San Juan 29-6 Unit 109N Well (API No. 30-039-PENDING), to be directionally drilled with a surface hole location in the NE/4 NW/4 (Unit C) and bottom-hole location in the NW/4 NW/4 (Unit D), and the San Juan 29-6 Unit 109P Well (API No. 30-039-PENDING), to be vertically drilled with a surface hole location in the NE/4 NW/4 (Unit C), within the W/2 of Section 32, Township 29 North, Range 6 West, NMPM, Rio Arriba County, New Mexico, and authorization to simultaneously complete and produce both wells from the Blanco-Mesaverde Gas Pool. Said area is located approximately 18 miles east of Blanco, NM. (Published March 7, 2024)
