**APPLICATION**

Permian Resources Operating, (“Applicant” or “Permian”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to amend Order No. R-22894 (“Order”) to allow additional time to commence drilling the initial well authorized by the pooling order. In support of its application, Permian states:

1. On October 9, 2023, the Division issued Order No. R-22894 in Case No. 22555, creating a standard 1,920-acre, more or less, horizontal well spacing unit in Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool [98220]) comprised of Section 36, Township 21 South, Range 26 East, and irregular Sections 31 and 32, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”). SPC Resources, LLC was designated as operator and Order No. R-22894 dedicates the Unit to the proposed initial **Fred State Com 403H** and **Fred State Com 442H** wells.

2. Permian has since acquired this property and requests that Order No. R-22894 be re-opened and amended to allow Applicant additional time to commence drilling the wells under the Order.

3. There is good cause for Applicant’s request for an extension of time to drill.

4. Under the Order, Applicant would be required to commence drilling the well by October 10, 2024, and therefore, asks for the deadline to commence drilling the well be extended for a year, to October 10, 2025.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on October 3, 2024, and, after notice and hearing as required by law, the Division enter an order extending the time for Permian to commence drilling the proposed initial well under the Order.
